The City Council convened in a Regular Meeting. City Clerk Leticia Vacek took the Roll Call noting the following Councilmembers present:

- 2. Mayor Nirenberg led the Pledge of Allegiance to the Flag of the United States of America.
- 3. Approval of Minutes for the City Council Regular Meetings of January 17-18, 2018 and the Special Meeting of January 25, 2018.

INDIVIDUAL ITEM FOR STAFF BRIEFING

City Clerk Vacek read the caption for Item 4:

4. Ordinance amending the City Code relating to First Amendment assembly and procession activities within the City; and authorizing a personnel complement and associated budget. [Andrew Segovia, City Attorney][Andrew Segovia, City Attorney]

City Attorney Andy Segovia presented a Power Point regarding First Amendment Assembly and Procession Laws, Policies, and Practices. He provided a timeline of the process for amending the City Code which included numerous meetings with the Free Speech Coalition and the community. He outlined the recommendations to include the Airport, Henry B. Gonzalez Convention Center, and the Alamodome. He mentioned that the Procession and Public Assembly Application and Information Website would be available in English and Spanish. He stated that additional improvements would be implemented such as a satisfaction questionnaire for processions and quarterly public meetings.

Mayor Nirenberg called upon the citizens registered to speak.

Amy Contreras stated that she was a member of the Free Speech Coalition and supportive of the recommendations.

Antonio Diaz stated that he had been a part of the process and was supportive of the recommendations. However, he noted that there was still more work to be done.

Nazirite Ruben Flores Perez addressed the City Council in support of the recommendations.

Joleen Garcia, Amy Kastely, and Graciela Sanchez, representing the Free Speech Coalition, spoke in support of the process and recommendations. Ms. Garcia thanked everyone involved and noted the issues that had prompted the need for change. Ms. Kastely added that she was pleased that traditional public spaces would continue to be available. She thanked the City Attorney's Office for their work.

Councilmember Treviño stated that he was proud of the process that had taken over a year to complete and thanked everyone involved. He noted that it was a work in progress and that there was still more work to be done.

Councilmember Saldaña recognized Councilmember Treviño for his leadership on the issue and the Free Speech Coalition for their work.

Councilmember Gonzales thanked everyone that worked on the process and spoke of the positive impact on cultural events.

Councilmember Brockhouse stated that he was pleased to support the revisions and recognized the Free Speech Coalition for their work. He noted that he would like to work on regulating public-private spaces to open their access to free speech.

Councilmember Viagran recognized everyone for their work and asked of the areas at the Convention Center that are rented out. Mr. Segovia stated that the spaces designated for assembly at the Convention Center were not rented out. He added that sidewalks and other public property were also available as long as they did not block entrances or exits.

Councilmember Perry stated that he would support the item today but still had some reservations due to the costs that would not be recouped.

Councilmember Courage stated that he was pleased that free speech would really be free in the City of San Antonio and that it was the role of the city to support constitutional rights.

Councilmember Shaw expressed concern that those that did not have the ability to pay for things had a limited voice. He stated that he was supportive of the amendments and asked of balances due for previous marches. Mr. Segovia responded that they would review same to see if they could eliminate the balances.

Councilmember Pelaez thanked the Free Speech Coalition and everyone involved for their work. He stated that there should be a balance between free speech and public safety.

Councilmember Sandoval recognized everyone involved and thanked the Free Speech Coalition for bringing solutions to the issues. She asked if any users had tested the website. Mr. Segovia stated that they would test the website once they started processing permits and would continue the dialogue with users. Councilmember Sandoval spoke of the need to make the public aware of the changes and to track progress.

Councilmember Treviño asked if costs would increase for those organizations that hosted

commercial processions. Mr. Segovia confirmed that costs would not increase for those events.

Mayor Nirenberg expressed his support and stated that he was pleased with the revisions that were a great example of local government working with the community.

Councilmember Treviño moved to adopt the Ordinance for Item 4. Councilmember Saldaña seconded the motion. The motion prevailed by the following vote:

18. City Manager's Report

FY 2018 1ST QUARTER FINANCIAL REPORT

Mrs. Sculley presented the 3+9 Report of the First Quarter Financial Report. Within the General Fund, she reported \$5.9 Million in additional revenue with \$1.6 Million in less expenses. She stated that the sales tax collected in January was \$1 Million below budget with CPS Energy Revenue collected at \$2.2 Million above budget. She projected a better ending balance for the FY 2018 General Fund of \$13.8 Million. She provided an overview of the Restricted Funds to include the Hotel Occupancy Tax (HOT), Development Services, and Solid Waste. She highlighted the Budget Initiatives and FY 2019 Recommended Budget Calendar.

SA SPEAK UP

Jeff Coyle presented information on the FY 2019 SA Speak Up Campaign noting that the goals were to let residents know how and when to participate in the budgeting process, and to solicit input on their needs and priorities. He provided an overview of the growth of the campaign since 2015 and mentioned that feedback was solicited in person and through digital marketing. He highlighted new initiatives for FY 2019 to include Influencer Meetups and Partnerships.

Mayor Nirenberg recognized City Attorney Andy Segovia who would be celebrating his birthday on March 6th. The City Council sang Happy Birthday to Mr. Segovia.
