She stated in May of 2017 SEP-HCP executed a Memorandum of Understanding (MOU) between the City of San Antonio, Bexar County and Texas Park and Wildlife to establish the coordination, administration, implementation and funding plan for the performance of the obligations in accordance with the HCP permit and the establishment of some Karst areas within Government Canyon in order to satisfy our initial conservation actions. She further stated they have executed an amendment to the initial MOU to extend agreement from September 30<sup>th</sup> to December 31, 2017 to continue working on the long term Interlocal Agreement between all parties.

Chris Holms, Texas Park and Wildlife, stated this amendment would not need to be considered by any Texas Park and Wildlife board/commission but will require directors signature.
