# FINAL Meeting Minutes City Council A Session

The City Council convened in a Regular Meeting. Deputy City Clerk Leticia Saenz took the Roll Call noting the following Councilmembers present:

- 2. Mayor Nirenberg led the Pledge of Allegiance to the Flag of the United States of America.
- 3. Approval of Minutes for the City Council Special Meeting of May 30, 2018 and the Regular Meeting of May 31, 2018

Councilmember Shaw moved to approve the Minutes for the City Council Special Meeting of May 30, 2018 and the Regular Meeting of May 31, 2018. Councilmember Treviño seconded the motion. The motion prevailed by the following vote:

# **POINT OF PERSONAL PRIVILEGE**

Mayor Nirenberg and Councilmember Saldaña presented an Official Commendation to Petty Officer Shelton Carter for his bravery and selflessness in coming to the aid of a citizen who was being robbed. Councilmember Saldaña recognized Petty Officer Carter and his fellow U.S. Navy Members that were present. Petty Officer Carter thanked the City Council for the recognition. Chief Joseph Yglesias stated that the U.S. Navy was grateful to the City Council for taking the time to recognize Petty Officer Carter. The City Council thanked Petty Officer Carter for his bravery and heroism.

### **CONSENT AGENDA ITEMS**

32, 33, 44, 45, 48, 26, and 55 were pulled for Individual Consideration. Treviño approve remaining moved to the Consent Agenda Items. Councilmember Shaw seconded the motion.

Mayor Nirenberg called upon the citizens registered to speak.

Jack M. Finger addressed the City Council in opposition to the San Antonio Tourism Public Improvement District (Item 42) and the Resolution opposing the inclusion of a citizenship question in the 2020 Census (Item 44).

Dr. Frederick Preston stated that he did not support or oppose the USAA Parking Garage (Item 25) but expressed concern with the construction noise. He asked that the noise be monitored so that there be minimum disruption to those that live and work downtown.

Terry Burns expressed concern that solar ready construction was optional in the 2018 Building Codes (Item 35A) noting the importance of solar ready features.

Councilmember Shaw highlighted Item 37 and recognized the newly appointed and reappointed Full and Part-Time Municipal Court Judges. Councilmember Treviño recognized Melanie Castillo on her appointment as a Part-Time Judge and thanked her for her service on the Ethics Review Board.

Mayor Nirenberg called upon Rene Dominguez. Mr. Dominguez recognized The Hut Group that would be relocating their headquarters to downtown San Antonio and creating 165 new high-paying jobs (Item 40). Councilmember Viagran expressed her support and stated that she was pleased with the new jobs they would be creating. Mayor Nirenberg thanked The Hut Group for their commitment to San Antonio.

Mayor Nirenberg and Councilmember Saldaña recused themselves from voting on Item 55 by exiting the Council Chambers and noting they submitted the recusal forms to the Deputy City Clerk.

Razi Hosseini stated that H-E-B Grocery had outgrown its distribution center located at IH-35 and Rittiman and had purchased land at the SW corner of E. Houston Street and S. Foster Road for a new distribution center. He noted that they planned to invest \$130 million over three years and employ 600 workers by 2020. He highlighted benefits of the project to include widening Foster Road from two lanes to four lanes and installing new traffic lights and striping. He mentioned that there were two options to reimburse H-E-B for design: Option 1) Two \$400,000 lump sum payments in FY 2019/2020; or Option 2) Reimbursement of property tax on an annual basis.

Mayor Pro Tem Treviño called upon the citizens registered to speak.

Charles E. Williams addressed the City Council in support of the project and stated that he was pleased with investments to be made by H-E-B.

Sylvia Alaniz, Eastgate Neighborhood Association President, stated that the organization was supportive of the project.

CJ Littlefield commended Councilmember Shaw for his efforts on the East Side and noted his support for the project.

Aubry Lewis, Denver Heights Neighborhood Association President, stated that they were in full support of the project.

TC Calvert, Neighborhoods First Alliance, reported that the Association was in support of the project and commended H-E-B Grocery for their commitment on the East Side.

Chris Dawkins, Lakeside Neighborhood Association President, spoke in support of the project and the future development that it would spur in the area.

James E. McNamara spoke in support of the project noting that he was pleased that the property would be developed.

Councilmember Shaw stated that he was very supportive of the project and asked of the infrastructure improvements and their benefit to the Fire Station. Chief Charles Hood stated that good infrastructure was important around any Fire Station and would help egress and ingress.

Councilmember Shaw moved to adopt the Ordinance for Item 55. Councilmember Viagran seconded the motion.

Councilmember Viagran commended Councilmember Shaw and stated that she was pleased to support the item due to the great commitment from H-E-B.

Councilmember Perry stated that this was a great project but he would like to fund it on a reimbursement basis.

Councilmember Perry moved to remove Option 1. Councilmember Brockhouse seconded the motion.

Chief Patrick Zepeda provided an overview of the 2018 Urban Area Security Initiative (UASI) Grant Program noting that it was created in 2003 in response to the 9/11 terrorist attack. He noted that the San Antonio Urban Area had received over \$42 million between 2004 and 2010. He reported that UASI Funding was lost in 2011, 2013, 2015, and 2016, while \$1.2 million was awarded in 2012, \$1 million in 2014, and \$1 million in 2017. He

indicated that funding for 2018 had increased to \$1.5 million and outlined the 2018 UASI Accomplishments and Security Projects. Councilmember Viagran thanked staff for their work to secure additional funds and asked of the strategy moving forward. Chief Zepeda spoke of the SA to DC Trip and their work to ensure that San Antonio received credit for its proximity to the border. Jeff Coyle added that a major point of emphasis has been to demonstrate the great need for funding in San Antonio.

Councilmember Saldaña commended Chief Zepeda for his work on increasing the grant funding and highlighted their efforts on the SA to DC Trip.

Councilmember Viagran moved to adopt the Ordinance for Item 26. Councilmember Saldaña seconded the motion. The motion prevailed by the following vote:

Mike Beldon, Chair of the Campaign Finance Task Force, stated that they recommended the disclosure of employer and occupation for all individuals donating \$100 or more to a campaign. He noted that they also recommended that campaign contributions be increased to \$750 per person per cycle for City Council and \$1,500 per person per cycle for the Mayoral Race effective July 1, 2018. Dr. Adriana Garcia, Chair of the Ethics Review Board, presented the Ethics Review Board recommended revisions to the Ethics Code and Municipal Campaign Finance Code. She highlighted the required disclosure of campaign contributions for parties seeking a Resolution of Support or No Objection for Multi-Family Housing Tax Credits; Approval of Revenue Bonds through the Housing Trust; and Economic Development Incentives by/through City-created entities. She stated that they also recommended adding a reporting period in April and October of each non-election year and in October of Election Years, as well as removing the 3-day reporting requirement. She added that if approved today; the recommendations would be effective January 1, 2019.

Councilmember Courage stated that he was pleased with the work of the Campaign Finance Task Force and Ethics Review Board.

Councilmember Viagran asked of effective dates. Andy Segovia replied that the ERB

Recommendations would be effective January 1, 2019 while the Campaign Finance Recommendations would be effective on July 1, 2018. Councilmember Viagran asked of the number of High Profile Contracts approved each year. Mr. Barthold replied that there were 42 High Profile Contracts solicited last year. Councilmember Viagran expressed concern with increasing the campaign contribution limits.

Councilmember Gonzales asked of the rationale on the increased campaign contribution limits. Mr. Beldon replied that the amount was discussed and agreed-upon by the Municipal Campaign Task Force. Councilmember Gonzales expressed concern with unintended consequences of some of the proposed changes.

Councilmember Brockhouse stated that the current system was not flawed and expressed concern that there were still too many unanswered questions.

Councilmember Brockhouse moved to postpone Item 32 until the end of August 2018. Councilmember Perry seconded the motion. The motion prevailed by the following vote:

Councilmember Courage moved that the City Council consider the employer/occupation disclosure requirement and increase in campaign contribution limits separately. Councilmember Brockhouse seconded the motion.

Councilmember Brockhouse stated that he was opposed to increasing campaign contribution limits in an effort to ensure a level playing field for all candidates.

Councilmember Treviño expressed support for the recommendations noting that a fair process had been utilized.

Councilmember Perry stated that he was opposed to increasing campaign contribution limits.

The motion to consider the employer/occupation disclosure requirement and increase in campaign contribution limits separately prevailed by the following vote:

Councilmember Saldaña seconded the motion.

Councilmembers Gonzales and Perry stated that they did not feel that the revision was necessary and that there was already a transparent process in place.

Councilmember Shaw stated that for-profit and non-profit organizations should be on a level playing field.

Councilmember Viagran moved to postpone Item 33 and send it to the Comprehensive Plan City Council Committee. Councilmember Treviño seconded the motion. The motion to postpone prevailed by the following vote:

**44.** Resolution opposing the inclusion of a citizenship question in the 2020 Census [Jeff Coyle, Director, Government and Public Affairs]

Megan Dodge spoke of the importance of an accurate Census Count noting that it determines the distribution of Federal Funds. She stated that it determines eligibility for assistance programs and forecasts transportation needs. She reported that the 2020 Census was redesigned with four key changes: 1) Reduced field canvassing; 2) Emphasis 3) Re-engineered online/telephone response; field operations; and 4) First self-respond is March 23, 2020 with Census Day being April 1st. She indicated that 24% of San Antonio Residents are likely not to self-respond at all or by the initial deadline. stated that the proposed questions were sent to Congress in late March and provided a brief history of the question regarding citizenship. She referenced a letter by six former Census Directors, pending lawsuits, and opposition by other entities on said question. She stated that the proposed Resolution opposing the inclusion of a citizenship question was approved by the City's Intergovernmental Relations Committee on June 13, 2018 and staff recommends approval of same. She noted that a letter opposing the inclusion of a citizenship question in the 2020 Census was received from Richard Perez, President and CEO of the San Antonio Chamber of Commerce.

Councilmember Viagran spoke of the importance of an accurate Census Count and stated that a question regarding citizenship would have a detrimental impact.

Councilmember Saldaña read a letter from Texas State Demographer, Lloyd Potter, in which he states that the inclusion of a citizenship question on the 2020 Census is of concern as it does not ensure the most complete and accurate count of the U.S. Population. Councilmember Saldaña stated that not having an accurate count has a negative effect on the ability to project population and transportation needs.

Councilmember Sandoval expressed concern that the citizenship question had not gone through the same development process as the other questions and with the additional cost. Councilmember Pelaez added that it was important to encourage as much participation as possible and he was in support of opposing the inclusion of a citizenship question in the 2020 Census. Councilmember Gonzales also expressed support for opposing the inclusion of a citizenship question in the 2020 Census.

Councilmember Perry asked what staff would do differently if the citizen question was included or not. Ms. Dodge replied that they would develop a plan during the Summer and that a Committee would be created to focus on strategy. Councilmember Perry stated that the process to get an accurate count would be the same whether or not the citizenship question was included.

Councilmember Brockhouse stated that there was uncertainty regarding the citizenship question's potential to depress response and he did not have enough information.

Councilmember Courage asked of the funding. Ms. Dodge replied that \$150,000 was allocated in 2010 and staff was developing a budget for the 2020 Census. Councilmember Courage noted that knocking on more doors would cost more money and that omitting the citizenship question would be one less barrier to people participating in the Census.

Councilmember Viagran moved to approve the Resolution for Item 44. Councilmember Sandoval seconded the motion. The motion prevailed by the following vote:

Melissa Ramirez presented Item Z-20 and stated that staff and the Zoning Commission recommended approval with the following conditions: 1) Business hours of operation shall not be permitted before 7:00 am or after 9:00 pm; 2) Downward facing lighting; and 3) No outdoor speakers or noise amplification. She reported that of 126 notices mailed; one was returned in favor and three in opposition.

Councilmember Courage confirmed that the Applicant was agreeable to all of the conditions Z-20 with conditions moved to approve Item the stated by Mrs. Ramirez. Councilmember Shaw seconded the motion. The motion to approve with conditions prevailed by the following vote:

[Ben Gorzell, Chief Financial Officer; Lori Steward, Director, Human Resources]

Councilmember Brockhouse asked of the Human Resources Department's level of input into future metrics. Lori Steward replied that the extent of their role was to select the consultant and that the consultant would work with the Mayor and City Councilmembers to develop metrics. Councilmember Brockhouse spoke of the importance of metrics and transparency and stated that he looked forward to having input in the future.

Councilmember Pelaez stated that it was not unusual to bring in a third party to assist with the evaluation and expressed his support. Councilmember Courage stated that this would create an objective tool to measure the achievement level of critical leaders within city government.

Mayor Nirenberg asked if the City Council would receive a market survey of similar positions. Ms. Steward confirmed that they would. Mayor Nirenberg asked of the cost of the contract. Ms. Steward stated that it was \$279,500 for an initial term of three years.

Councilmember Brockhouse moved to adopt the Ordinance for Item 45. Councilmember Viagran seconded the motion. The motion prevailed by the following vote:

**48.** Ordinance approving an agreement with the Office of Urban Redevelopment San Antonio (OUR SA) for the administration of activities related to the 2017-2022 Neighborhood Improvements Bond Program. [Peter Zanoni, Deputy City Manager]

Councilmember Perry stated that he had requested that various items be included in the checklist for the Memorandum of Understanding (MOU). Veronica Soto presented an overview of the MOU between the City of San Antonio and the Office of Urban Redevelopment San Antonio (OUR SA). She noted that it would formally establish the administration of activities and processes for the implementation of the \$20 million 2017-2022 Neighborhood Improvements Bond Program. She indicated that the MOU detailed the division of responsibilities and staffing plan. Additionally, it provided the OUR SA Board and City Staff the authority to negotiate and execute real estate contracts not to exceed \$100,000 in non-refundable earnest money contracts. She added that the OUR SA Board unanimously voted to approve the MOU and city staff also recommended approval.

City Council A Session Meeting Minutes June 21, 2018

Councilmember Perry stated that this was a new program and he would like for the City Council to be involved at all steps in the process. Peter Zanoni stated that staff recommended taking contracts in excess of \$1 million to the Audit and Accountability Council Committee.

Councilmember Perry moved to adopt the Ordinance with the condition that contracts in excess of \$1 million be reviewed and approved by the Audit and Accountability Council Committee. Councilmember Brockhouse seconded the motion.

Councilmember Courage noted that high profile contracts which include those in excess of \$1 million are already presented to the Audit and Accountability Council Committee.

Councilmember Saldaña expressed concern that the issue was not discussed with the City Council prior to the meeting.

Mayor Nirenberg stated that he did not support the amendment as there were already challenges with creating affordable housing.

The motion by Councilmember Perry failed by the following vote:
