# FINAL Meeting Minutes City Council A Session

The City Council convened in a Regular Meeting. City Clerk Leticia Vacek took the Roll Call noting the following Councilmembers present:

- 1. The Invocation was delivered by Sister Sharon Altendorf, Union of Sisters of the Presentation of the Blessed Virgin Mary, guest of Councilmember Shirley Gonzales, District 5.
- 2. Mayor Nirenberg led the Pledge of Allegiance to the Flag of the United States of America.
- **3.** Approval of Minutes for the City Council Regular Meetings of August 8 9, 2018.

Councilmember Treviño moved to approve the Minutes for the City Council Regular Meetings of August 8-9, 2018. Councilmember Shaw seconded the motion. The motion prevailed by the following vote:

# POINT OF PERSONAL PRIVILEGE

Mayor Nirenberg recognized August 30, 2018 as Manu Ginobli Day in San Antonio. He stated that Manu was one of the most beloved Spurs Players of all time and highlighted his many accomplishments. He mentioned that Manu's grit, grind, and sacrifice for the team exemplified the Spurs' Way. He added that Manu would always have a preeminent place in the hearts of Spurs Fans around the world and especially in San Antonio. He presented a Proclamation to Shermeka Hudson, representing Spurs Sports & Entertainment.

Mayor Nirenberg recognized the Rey Feo Consejo Educational Foundation noting that they raise money for college-bound youth through their 10-day event at Market Square known as "Fiesta de los Reyes." He called upon Charlie Garza, Regent of the Rey Feo Consejo Educational Foundation. Mr. Garza spoke of the results of this year's Market Square partnership noting that both the city and the organization netted almost double of the 2017 proceeds. He added that this Fall, the Scholarship Foundation will be awarding \$300,000 in awards for the 2018-19 School Year. He recognized Sara Blaine, a current Rey Feo Scholar and Junior at UTSA who has been able to pursue higher education. Ms. Blaine and thanked the Rey Feo Consejo Educational Foundation for the award.

Councilmember Courage stated that he had been a Public School Teacher for many years and was opposed to another Local Charter School being built that would diminish resources available for the Public School System.

Councilmember Pelaez thanked Great Hearts America for their investment in District 8. He noted that his children attended a Charter School in San Antonio and highlighted the rigorous curriculum and high standards of Charter Schools.

Councilmember Perry stated that this was an opportunity to provide quality education and another choice to parents and children.

Councilmember Brockhouse expressed his support noting that this was State Financing and not City Funds. He noted that there were larger problems with the school system education funding that he hoped would be addressed through the Legislature.

Councilmember Viagran asked if these Resolutions were always brought before the City Council. Troy Elliott replied that they could be approved by the full City Council or by signature of the Mayor.

Councilmember Saldaña expressed his support noting that Charter Schools were Public Schools. He stated that he had witnessed school districts improving their quality due to the introduction of new concepts and Charter Schools.

Councilmember Treviño stated that he would support the Resolution but would like to see property tax reform and public school financing addressed at the State Level.

Mayor Nirenberg stated that this was not a choice between Public Schools and Charter Schools and that there was no risk to the City of San Antonio. He noted that the City of San Antonio had approved financing for other educational institutions and was supportive.

Councilmember Pelaez moved to approve the Resolution for Item 26. Councilmember Brockhouse seconded the motion. The motion prevailed by the following vote:

# **2018 WORLD HERITAGE FESTIVAL**

Mrs. Sculley reported that next week, the World Heritage Office would kick off the 3rd Annual World Heritage Festival to be held September 5-9, 2018. She noted that the five-day event would celebrate the anniversary of the San Antonio Missions' Designation as a

UNESCO World Heritage Site inscribed on July 5, 2015. She added that the goal of the World Heritage Festival was to promote the San Antonio Missions and highlight their significance, as well as celebrate the inscription of the San Antonio Missions onto the World Heritage List. She highlighted various events that would occur throughout the week and thanked the many partners including Bexar County, San Antonio River Authority, National Park Service, Mission Heritage Partners, and the San Antonio Food Bank.

# "WALK ON THE RIVER" FILM PREMIERE

Mrs. Sculley reported that on Friday, August 17th, the Jo Long Theatre at the Carver served as the host venue for the premiere of the film, "Walk on the River: A Black History of the Alamo City" to a sold out crowd of 650 people. She noted that the documentary was produced by Local Film Company, Melaneyes Media, that highlights the history and contributions that African-Americans have made to the fabric of San Antonio. She stated that Melaneyes Media was devoted to creating culturally enriching, educational Black Films and Videos. She added that the film premiere was an Official Tricentennial Event funded through crowdfunding, business sponsorships, and donations from the community.
