The City Council convened in a Regular Meeting. City Clerk Leticia Vacek took the Roll Call noting the following Councilmembers present:

Additionally, Mrs. Vacek noted that the total number of votes cast was 12,048 and the total number of registered voters for this area was 26,020. She stated that the voter turnout for the Lackland Airforce Base/Medina Training Annex Special Election was 46.30%.

Mrs. Vacek stated that the results for the Charter and Special Elections noted within the report did not include the tabulation of 908 County-wide provisional ballots that were still outstanding. She indicated that according to Bexar County Elections Administrator Jacque Callanen, "There is no contest of yours that have a slim margin which could possibly be affected." Therefore, Mrs. Vacek noted that none of the municipal election results would be affected by the tabulation of these provisional ballots as none had margins smaller than 5,451 votes. Mrs. Vacek added that once the provisional ballots had been tabulated; a final ordinance would be submitted and complete results would be updated. She recommended that the City Council accept the Canvass Report Results of the Tuesday, November 6, 2018 City of San Antonio Charter and two Special Elections with the stipulation that applicable provisional ballots be added when available from the Bexar County Elections Department.

Councilmember Shaw excused himself from the meeting at this time.

Mayor Nirenberg called upon the citizens registered to speak on Items 4A-C.

Stanley Mitchell spoke of San Antonio Making Bureaucracies Accountable (SAMBA's) support for Charter Amendment B which indicates that there is no confidence in the current administration.

Jack M. Finger expressed concern with the Bexar County Elections Department noting that he and several other poll watchers were excluded from the tabulation room.

Councilmember Treviño moved to approve Items 4A, 4B, and 4C. Councilmember Courage

seconded the motion. The motion to approve prevailed by the following vote:

Mayor Nirenberg addressed Item 17 at this time. City Clerk Vacek read the caption for Item 17:

17. Resolution supporting women's safety, health, and economic opportunity in the City of San Antonio. [Maria Villagomez, Assistant City Manager; Alex Lopez, Interim Director, Office of Equity]

Maria Villagomez presented the resolution supporting women's safety, health and economic opportunities sponsored by Councilmembers Viagran, Gonzales, and Sandoval. She highlighted policy priority areas to include: 1) Domestic Violence & Sexual Assault; 2) Health Outcomes; and 3) Economic and Business Opportunities. She reported that 51% of San Antonio Residents were female. She stated that the cases of domestic violence and sexual assault had increased in recent years and had a disproportional impact on women. She outlined health outcomes to include reducing the teen pregnancy rate and indicated that maternal and child health had stalled in recent years. She highlighted the importance of supporting women in creating and growing businesses and completing employment training, while providing role models and mentors for future generations. She reported that through the Small Business Economic Development Advocacy Program (SBEDA); women in city contracting had increased from 3% in 2011 to 17% in 2017. Lastly, she presented an equity strategy that would implement a shared understanding and definitions; build an internal infrastructure; and use data to develop strategies and drive results.

Mayor Nirenberg called upon the citizens registered to speak.

Sophie Torres, Vice President of Government Affairs for the San Antonio Hispanic Chamber, spoke in support of the Resolution.

Monica Treviño-Ortega representing the Latina Leadership Institute spoke in support of the Resolution.

Brielle Insler stated that she represented a group of over 190 women entrepreneurs in support of the Resolution.

Councilmember Viagran thanked Councilmembers Gonzales and Sandoval for their collaboration on the Resolution. She also recognized City Manager Sculley, Maria Villagomez, Alex Lopez, and Liz Provencio, and Marisa Bono for their work and leadership. She stated that it was important to address domestic violence, sexual assault, health outcomes, and economic business opportunities for women. She highlighted the work of organizations such as the Latina Leadership Institute and Mayor's Commission on the Status of Women, and noted the strategies to embed equity in the entire city organization. She spoke of the need to increase the number of applications

and appointments of women to serve on City Boards and Commissions and thanked all that worked on the Equity Impact Assessment for same.

Councilmember Gonzales stated that she was pleased to move this Resolution forward. She spoke of the issues that need to be addressed within the areas of health, domestic violence and child abuse.

Councilmember Sandoval stated that she was proud to support the Resolution that she was proud to support and recognized the importance of women's equity. She recognized the Office of the City Clerk and the Office of Equity for their work on the Equity Impact Assessment for Boards and Commissions.

Councilmember Pelaez expressed support for the Resolution. He stated that it was important to address issues of domestic violence and commended Councilmembers Viagran, Gonzales, and Sandoval for their work.

Councilmember Courage stated that he was supportive of the Resolution and spoke of the need to address gender bias. Councilmember Treviño expressed his support and recognized the many female leaders and board and commission members representing District 1. Councilmember Saldaña noted his support for the Resolution and recognized the many female leaders throughout the community.

Councilmember Brockhouse stated that he was honored to support the Resolution and thanked Councilmembers Viagran, Gonzales, and Sandoval for bringing it forward. Councilmember Perry expressed his support for the Resolution and highlighted the service of women in the military.

Mayor Nirenberg expressed his support for the Resolution and highlighted the work of the City Council on equity. He spoke of the importance of action and stated that this was a public pledge to ensure prosperity for all San Antonians. He recognized Sheryl Sculley, Leticia Vacek, Liz Provencio, Maria Villagomez, Lori Houston, and Marisa Bono for their work. He commended Councilmembers Viagran, Gonzales, and Sandoval for leading this effort and recognized his wife, Erika for her work with women and girls in the community.

Councilmember Viagran moved to approve the Resolution. Councilmember Gonzales seconded the motion. The motion to approve prevailed by the following vote:

Mayor Nirenberg and Councilmembers Viagran, Gonzales, and Sandoval excused themselves from the meeting. Mayor Pro Tem Courage presided. He addressed Item 20 at this time.

City Clerk Vacek read the caption for Item 20.

Mayor Pro Tem Courage called upon the citizens registered to speak.

Jack M. Finger expressed concern that the City of San Antonio was opposed to reducing the roll back rate noting the increase in property values and taxes.

Joleen Garcia, Yaneth Flores, and Austin Dolan representing Working Texans for Paid Sick Time spoke in support of the inclusion of a priority item entitled "Preserving Local Decision Making." Ms. Garcia noted that the Paid Sick Time Ordinance was critical and would improve public health. She stated that they would be prepared to defend the Paid Sick Time Ordinance in the State Legislative Session.

Jeff Coyle provided an overview of the City Council-approved State Legislative Program. Councilmember Pelaez asked if there would be an effort related to the Paid Sick Time Ordinance. Mr. Coyle replied that there would be a statement regarding supporting the city's ability to make local decisions. However, he indicated that there would likely be discussion on the issue at the State Level and would solicit feedback from the City Council regarding same. Councilmember Pelaez spoke of the need to address property tax appraisals and advocating for effective and impactful tax reform.

Mayor Nirenberg returned and presided over the meeting.

Councilmember Saldaña spoke of the importance of protecting local authority and Ordinances passed by the City Council. Councilmember Courage stated that it was necessary for the State to better fund public education noting that it was an economic engine that drives the community.

Councilmembers Viagran, Gonzales, and Sandoval re-entered the meeting.

Mayor Nirenberg thanked the Intergovernmental Relations Council Committee for their work and noted that it was important to pursue better outcomes for San Antonio.

Councilmember Pelaez moved to adopt the Ordinance for Item 20. Councilmember Treviño seconded the motion. The motion to approve prevailed by the following vote:

Mayor Nirenberg addressed Item 14 at this time. City Clerk Vacek read the caption for Item 14:

Mayor Nirenberg called upon the citizens registered to speak on Item 14.

Cynthia and Mark Spielman spoke in support of the amendments noting that the guidelines for IDZ would make a great difference.

Shawn Price stated that he was representing the West End Hope in Action Neighborhood Association in support of the amendments.

Frederica Kushner stated that she lives in the Tobin Hill Neighborhood and was supportive of the amendments. She noted that the revisions to IDZ would greatly help their neighborhood.

Cherise Rohr-Allegrini representing the Lavaca Neighborhood Association spoke in support of the amendments.

Dr. Christine Drennon spoke in favor of the two new zoning codes for R-1 and R-2 noting that it was important to create tools that allow development while preserving neighborhoods.

Anne Englert stated that she lived in the Dellview Neighborhood and was supportive of the amendments.

Cosima Colvin stated that she was representing the Tier 1 Neighborhood Coalition in support of the amendments.

Tony Garcia stated that he had served on the IDZ Task Force and was supportive of the amendments.

Grace Rose Gonzalez spoke in favor of the amendments noting that she was pleased with the IDZ recommendations that would help preserve neighborhoods.

Rosemary Anguiano-Zuniga stated that she was representing the Mission San Jose Neighborhood Association in support of the amendments.

Yaneth Flores representing the Esperanza Peace and Justice Center stated that they were supportive of the R-1 and R-2 additions that would allow for homes to be built on smaller lots than currently allowed.

Rose Hill, President of the Government Hill Neighborhood Association, spoke in favor of the amendments; specifically the new R-1 and R-2 Zoning Designations.

Dawn Hanson stated that she was concerned with the required parking for IDZ and asked that it be removed.

Councilmember Treviño requested a brief presentation. Michael Shannon provided overview of updates to the Infill Development Zone (IDZ) regulations. He noted that the current IDZ regulations were only allowed inside Loop 410 and there were neighborhood concerns regarding density, lack of parking, and visual concerns. He stated task force 15-member was created in October 2017 comprised of neighborhood representatives and members of the development community. He outlined recommendations in which three categories would be created for IDZ based on intensity of and size. He highlighted updates for Mixed-Use Districts that include site plan requirements and would provide an alternative to IDZ. Lastly, he outlined the creation of R-1 and R-2 Zoning for Single-Family Districts. Councilmember Treviño thanked everyone for their work and submitted an example of IDZ site plans approved in District 1. He noted that the amendments were supported by developers and would protect neighborhood plans. He commended Chrissy McCain from his staff for her great work.

Councilmember Treviño moved to adopt the Ordinance for Item 14. Councilmember Courage seconded the motion.

Councilmember Sandoval thanked everyone for their work on the amendments and asked if the reduced parking requirements applied to residential and commercial development. Mr. Shannon confirmed that it applied to both.

Councilmember Perry expressed concern with street parking that impedes traffic and blocks emergency vehicles.

Councilmember Shaw re-entered the meeting at this time.

Councilmember Saldaña thanked everyone for their work and stated that he had shifted his opinion to support the new R-1 and R-2 Zoning Designations. He made a friendly amendment to: 1) Establish a maximum lot size of 1,999 square feet for R-1 and a maximum lot size of 2,999 square feet for R-2; 2) Remove the open space requirements for R-1 and R-2; and 3) Establish a maximum size of 2,999 square feet for a zoning request for R-1 and R-2, which shall not apply to city-initiated zoning cases. Councilmembers Treviño and Courage accepted the friendly amendment.

Councilmember Viagran expressed her support for the amendments and thanked everyone for their work. Councilmember Shaw stated that they had been working on IDZ Amendments for some time and expressed his support. Mayor Nirenberg thanked everyone for their work and expressed his support.

The motion to approve Item 14 with the friendly amendment prevailed by the following vote:

Councilmember Saldaña highlighted the project as a great example of providing affordable housing options in the urban core. Veronica Soto stated that the project had receiving a 9% Low-Income Housing Tax Credit Award and the Local Initiatives Support Corporation (LISC) was one of their partners. Councilmember Saldaña noted the 9 units that would be provided at 30% of the Area Median Income (AMI) and was pleased that there would be multiple low-income housing options. Jennifer Gonzales, Executive Director of the Alamo Community Group, stated that there were many partners that made the project happen. She stated that they had identified the location due to its proximity to one of the five Regional Centers identified in the Comprehensive Plan. Lori Houston spoke of the various incentives to include the Center City Housing Incentive Policy (CCHIP), Midtown Tax Increment Reinvestment Zone (TIRZ), and 9% Housing Tax Credit. Councilmember Saldaña expressed his support for the project that would provide housing near people and jobs.

Councilmember Treviño expressed his support for the project and thanked the many partners that made the project a reality. Councilmember Courage noted his support for the project and stated that he hoped that other suitable properties could be identified in the Downtown Area for affordable housing.

Councilmember Saldaña moved to adopt the Ordinance for Item 21. Councilmember Treviño seconded the motion. The motion to approve prevailed by the following vote:
