## Citizens to be Heard

<u>Cynthia Spielman</u>, representing the Tier One NA, read a letter in support of the amendments of the site plan requirements. She stated requiring the site plan focuses developer's vision and encourages an early conversation between the developer's needs and the neighborhoods expectations. The height plan requirement ensures the exiting neighborhood is respected and not overwhelmed.

<u>Robert Fox</u>, David Weekly Homes Land Manager, stated that they were generally in support, but stated that they were concerned that less density would lead to more costly housing prices, were generally in support of the site plan requirements, stated that the height limitations should be context sensitive and not arbitrary.
