The City Council of San Antonio convened in the “B” Room of the Municipal Plaza Building. City Clerk Leticia Vacek took the Roll Call noting the following Councilmembers present:

1. Interview of Applicants and selection of up to 3 Finalists for the District 2 City Council Vacancy. [Leticia M. Vacek, City Clerk]

Mayor Nirenberg welcomed the District 2 Applicants and thanked them for submitting their applications. He stated that each Applicant would be given three minutes to provide a statement regarding their interest in serving and state their background and qualifications. He noted that an additional seven minutes would be provided for City Council questions and answers.

City Clerk Leticia M. Vacek stated that the Notice of Vacancy was published in the Express-News in English and Spanish on Sunday, December 16, 2018. Additionally, the Notice of Vacancy was published on-line, on the City's public access channel, and in the city kiosks by close of business on December 17, 2018. She noted that applications, letters of interest, resumes, supplemental documentation of residency, and Financial Disclosure

Mayor Nirenberg announced that the meeting would resume in the Council Chambers for Citizens to be Heard.

**CITIZENS TO BE HEARD**

Mayor Nirenberg called upon the citizens registered to speak.

Perry Donop spoke in opposition to The Alamo Master Plan and spoke of honoring Alamo History.

Mark Perez spoke of wasteful practices in the Fire Department and noted concern with permitting practices.

Nazirite Ruben Flores Perez spoke of the end of time and Biblical Law.

Professor Judith Norman spoke of current events regarding Israel and invited the City Council to attend a DreamWeek Panel regarding San Antonio's relationship with Israel.

Gregory Jackson asked the City Council to involve residents when filling City Council Vacancies.

Keith Toney expressed concern with the selection process for the District 2 Council Vacancy and cautioned against candidates that were not residents of the District.

Rose Hill asked the City Council to involve residents when filling City Council Vacancies.

Tyrone Darden expressed concern with the District 2 Vacancy process and asked that residents be involved.

Ken Lowe asked the City Council to involve residents when filling City Council Vacancies.

Rep. Barbara Gervin-Hawkins spoke of the community process to recommend a District 2 Candidate and noted the importance of citizen inclusion in government processes.

Floyd Wilson noted the importance of a strong succession plan and asked that the District 2 community be more involved in future processes.

Liz Franklin expressed concern that District 2 Residents were not sufficiently involved in filling the District 2 Vacancy.

Antonio Diaz asked that the Christopher Columbus statue be removed from Columbus Park and spoke of crimes against Indigenous Peoples.

Angie Garcia expressed concern with the selection process for the District 2 Council Vacancy and noted the importance of community engagement.

Brandon Burkhardt spoke in opposition to moving the Cenotaph and expressed concern with community engagement.

There being no further discussion, Mayor Nirenberg adjourned the meeting at 7:04 pm.
