The City Council convened in a Regular Meeting. City Clerk Vacek took the Roll Call noting a quorum with the following Councilmembers present:

PRESENT: 10 - Mayor Nirenberg, Treviño, Hall, Viagran, Gonzales, Brockhouse, Sandoval, Pelaez, Courage, and Perry

ABSENT: 1 - Saldaña

Mrs. Vacek announced that Councilmember Saldaña was absent as he was taking his son to the doctor.

- 1. The Invocation was delivered by Pastor James Dew, St. John's Lutheran Church, guest of Councilmember Roberto C. Treviño, District 1.
- 2. Mayor Nirenberg led the Pledge of Allegiance to the Flag of the United States of America.
- **3.** Approval of Minutes of the City Council Regular Meetings of February 20 21, 2019.

Councilmember Treviño moved to approve the Minutes of the City Council Regular Meetings of February 20-21, 2019. Councilmember Hall seconded the motion. The motion to approve prevailed by the following vote:

POINTS OF PERSONAL PRIVILEGE

Mayor Nirenberg observed a moment of silence for Tito Bradshaw who was killed by a drunk driver while riding his bicycle in San Antonio earlier in the week. Councilmember Gonzales spoke of the importance of moving forward with Vision Zero Policies to make streets safer for all users.

Mayor Nirenberg presented a Certificate of Appreciation to former CPS Energy Board Member Homer Guevara and thanked him for his many years of service. Mr. Guevara stated that he was pleased to serve and appreciated the recognition.

Councilmember Hall recognized District 2 City Council Candidate Keith Toney who was shadowing him. He also recognized Kim Abernathy, President and CEO of Child Safe.

Ms. Abernathy highlighted their Cardboard Kids Campaign to raise awareness of the issue of Child Abuse. Mayor Nirenberg and the City Council thanked Ms. Abernathy for their efforts.

Councilmember Viagran highlighted the Viva SA Healthy Corner Store Initiative approach to improve the availability, quality, and affordability of fresh fruits and vegetables in neighborhood corner stores. She invited everyone to join the kickoff event tomorrow at 9:00 am at the Red Rooster Mart in District 3. She also noted that April was National Poetry Month and invited everyone to attend the "Viva Poesia Notas Sabrosas" Event at the Mission Marquee Plaza on Saturday, April 6th.

Councilmember Sandoval highlighted the HIV Know Your Status Campaign and noted that one in seven people are infected with HIV and do not know they have it. She challenged all of the City Councilmembers to a competition on getting residents to get tested.

CONSENT ITEMS CONCLUDED

ACTION ITEMS FOR STAFF BRIEFING

City Clerk Vacek read the caption for Item 4:

4. Briefing on legislation filed in the 86th Regular State Legislative Session. [Carlos Contreras, Assistant City Manager; Jeff Coyle, Director, Government & Public Affairs]

Jeff Coyle presented a power point and stated that 7,456 Total Bills and Joint Resolutions were filed. He provided an overview of the bills related to Property Taxes, Public School Finance Reform, Military Protection, Transportation, and Other City Related Issues.

Mayor Nirenberg called upon the citizens registered to speak.

Joleen Garcia, Jesse Gloria, and Cecilia Gutierrez representing the Coalition Against SB 15 spoke in opposition to Senate Bill (SB) 15 noting concerns that it erodes the rights of citizens and local control in San Antonio. Ms. Garcia expressed concern that it would eliminate Paid Sick Time for San Antonians.

Jack M. Finger expressed concern with the continued increase in property taxes and spoke against moving the Cenotaph at The Alamo.

Councilmember Sandoval asked of the bill related to Cable Fees and if other cities had weighed in on it. Mr. Coyle spoke of the great financial impact it would have on the City of San Antonio. He noted that various cities to include Houston had expressed concern with it since it would have an even greater impact on their city. Councilmember Sandoval stated that she had received a text from Councilmember Saldaña who was privileged to have Paid Sick Leave so that he could take time off to care for his son. He requested that the City Councilmembers state their position regarding SB 15. Councilmember Sandoval stated that she was supportive of Paid Sick Leave and expressed concern with the Non-Discrimination Ordinance (NDO) portion being folded into one of the proposals. She stated that she would like for the City of San Antonio to take a position on SB 15 and asked that another Legislative Update be brought before the City Council with possible action.

Councilmember Courage spoke in support of Paid Sick Leave and noted concern for the State taking away local control. Councilmember Treviño also noted support for Paid Sick Leave and stated that he was opposed to the State taking away local control.

Councilmember Gonzales asked if any action was necessary at this time. Mr. Coyle stated

that the State Legislative Agenda was approved by the City Council and that the Intergovernmental Relations Council (IGR) Committee had chosen not to take a position on SB 15 but to continue to monitor it closely. Councilmember Gonzales expressed support for Paid Sick Leave and making it a priority.

Councilmember Viagran asked that staff stay abreast of the bill filed by Representative Bernal related to Legacy Homeowners. She stated that they needed more information about the various bills related to SB 15 and how they work together.

Councilmember Hall stated that it was best to take a general approach as opposed to specific language due to the constant changes occurring in the Session.

Councilmember Sandoval asked of the position the City Council adopted related to Local Control. Mr. Coyle replied that he did not have the exact language but that it provided the ability for Local Elected Officials to pass Ordinances and Policies that they believe are in the best interest of their community.

Councilmember Brockhouse stated that he was generally supportive of Local Control; however, he asked for consistency to apply it across the board.

Councilmember Perry stated that the IGR Committee followed a process and that anyone was welcome to attend their meetings and ask questions.

Councilmember Pelaez stated that they should send the issue back to the IGR Committee for further vetting.

Mayor Nirenberg asked of the status of SB 1152 and its fiscal impact. Mr. Coyle replied that it was heard in the House this week and left pending in Committee but had passed out of Committee in the Senate. He noted that there would be an \$8 million reduction in revenue to the City of San Antonio. Mayor Nirenberg asked if the impact of HB 2 and SB 2 related to Property Taxes had been conveyed to the City's Delegation. Mr. Coyle replied that it had been conveyed. Mayor Nirenberg asked that SB 15 be sent back to the IGR Committee and expressed support for defending the city's NDO.

No action was required for Item 4.

Councilmember Treviño recused himself from voting on Item 6 by exiting the Council Chambers and noting he submitted the recusal forms to the City Clerk.

Councilmember Viagran asked of the partnership with the Bexar County Appraisal District (BCAD). Troy Elliott replied that they were unable to fund any part of the study but would cooperate on the study.

Councilmember Pelaez submitted a letter for the record from the Bexar Appraisal District indicating that they would work cooperatively with the City of San Antonio's comprehensive study of local ad valorem property tax appraisals.

Councilmember Perry expressed support for the study noting that he had received many concerns from his constituents regarding the appraisal process. Councilmember Courage also noted his support and stated that this was part of a larger plan to provide meaningful tax relief.

Councilmember Sandoval expressed support noting the need for additional information to address the problem.

Councilmember Pelaez moved to adopt the Ordinance for Item 6. Councilmember Hall seconded the motion. The motion to approve prevailed by the following vote:

Councilmember Sandoval asked how the services had helped reduce accidents. Debra Ojo highlighted the Consultant Services and Outcomes. She reported accomplishments to include a 50% reduction in workplace preventable collisions within one year. She noted that they had improved the safety culture in all Solid Waste Management Divisions and awareness of all City Employees. Councilmember Sandoval stated that she would like to have a further discussion on safety requirements for outside contractors. Ms. Ojo replied that it was a component of the system and they would work with TCI to identify the contractors.

Councilmember Perry asked of the cost of ISO Certification. Ms. Ojo replied that it was \$119,000 over five years. Councilmember Perry noted that the safety programs could reduce accidents without the ISO Certification.

Councilmember Sandoval moved to adopt the Ordinance for Item 28. Councilmember Viagran seconded the motion. The motion to approve prevailed by the following vote:

30. City Manager's Report

Mr. Walsh reported that the National Civic League announced San Antonio as one of the 20 Finalists for the 2019 All-America City Award. He noted that in the last decade; the City of San Antonio has won the award four times. He stated that the Annual Award recognizes communities that work together to prioritize and achieve results. He indicated that this year; Metro Health collaborated with Human Services and Government & Public Affairs to highlight their collective work focused on strategies to improve health and increase community engagement in neighborhood-based programming. He stated that Metro Health highlighted its "End Stigma End HIV Alliance" and the Fast Track Cities Initiatives to meet

the challenge of increasing the number of people living with HIV who know their status. He noted that Human Services highlighted its Immigration Services, Faith Based Initiatives, and Interfaith Welcome Coalition Partnership, to meet the challenge of increasing the cooperation of stakeholders to address immigrant, refugee, and asylum seekers in the city. He indicated that the Government & Public Affairs Department highlighted the creation of SA Speak Up to meet the challenge of increasing civic participation from residents. He added that the finalists would present their applications at the 2019 NCL All-America City Awards Event in Denver, Colorado in June with the 10 winning cities announced at the closing ceremony.
