The City Council convened in a Regular Meeting. City Clerk Leticia Vacek took the Roll Call noting a quorum with the following Councilmembers present:

PRESENT: 11 - Mayor Nirenberg, Treviño, Hall, Viagran, Saldaña, Gonzales, Brockhouse, Sandoval, Pelaez, Courage, and Perry

Mrs. Vacek announced that Councilmembers Brockhouse and Perry would be absent from the morning portion of the meeting. She stated that Councilmember Brockhouse's wife was ill and Councilmember Perry was receiving an award from the School of Science and Technology.

- 1. The Invocation was delivered by Captain Saul Rappeport, Chaplain, JBSA- Lackland, guest of Councilmember Rey Saldaña, District 4.
- 2. Mayor Nirenberg led the Pledge of Allegiance to the Flag of the United States of America.
- 3. Approval of Minutes of the City Council Regular Meetings of April 3 4, 2019

Councilmember Saldaña moved to approve the minutes of the City Council Regular Meetings of April 3-4, 2019. Councilmember Treviño seconded the motion. The motion to approve prevailed by the following vote:

POINTS OF PERSONAL PRIVILEGE

Councilmember Viagran recognized St. Leo the Great Catholic Church on their 100-Year Anniversary. She stated that St. Leo's was her home parish and spoke of their great work in the community. She recognized Father Frank Macias. Father Macias thanked the City Council for the recognition and support.

Councilmember Treviño recognized Mark Richter who passed away on Sunday. He stated that Mr. Richter was a great force for Arts and Culture in San Antonio and would be greatly missed.

Mayor Nirenberg recognized Katelyn Underbrink, Marcus Peoples, and Mia Loseff who had served as Interns in his office and thanked them for their work.

CONSENT AGENDA ITEMS

Items 20 and 22 were pulled for Individual Consideration. Councilmember Sandoval moved to approve the remaining Consent Agenda Items. Councilmember Treviño seconded the motion.

Mayor Nirenberg called upon Mr. Jack M. Finger to speak.

Councilmember Hall highlighted the Lockwood and Dignowity Park Project (Item 10).

Mayor Nirenberg thanked Booz Allen Hamilton for their investment in San Antonio (Item 19).

City Clerk Vacek read the caption for Item 20:

Megan Dodge presented an overview of the Master Interlocal Agreement (ILA)

Amendments with Bexar County. She reported that the city had entered into a Master ILA with Bexar County in 2013 and consolidated several service agreements into one. She stated that the Master ILA expired in September 2018 and City Council approved a new Master ILA in December 2018. She noted that the proposed additions to the Master ILA included: 1) Fire Services and Inspection; 2) Food Services and Permitting; and 3) Magistration. She mentioned that the Fire and Food Services would follow the term of the Master ILA through September 30, 2019; while the Magistration component would terminate on January 1, 2020.

Councilmember Sandoval requested that staff provide updates on the Magistration Components to the Public Safety City Council Committee. She asked where the magistration would take place. Ms. Dodge replied that it would occur through video magistration or at the County Facility. Councilmember Sandoval asked of the custody of arrestees. Ms. Dodge explained that the arresting agency would have custody until the time of magistration at which point they would remain in the custody of the Bexar County Sheriff's Office. Judge Margarita Pol added that if an individual was on bond; they would be supervised by a County Department and the process would remain as is currently.

Councilmember Viagran stated that she would like to ensure that there is no additional burden on City Judges. Michael Lozito of Bexar County stated that they were working through the process and that the only thing that would change would be the magistration. Councilmember Viagran spoke of the need to monitor the workload of City Judges and asked of criminal trespassing. Assistant Chief Treviño stated that SAPD would continue to arrest for criminal trespass violations if they had probable cause.

Councilmember Hall asked how the payment amount of \$294,455 was determined. Ms. Dodge replied that it was 35% of the total cost of the Magistrate Court of \$841,300.

Councilmember Saldaña asked of bail hearings. Fred Garcia stated that the City would perform all of the bail hearings primarily through the use of video. He confirmed that this was an 8-month Pilot Program that would be assessed for feasibility of continuing in the future.

Mayor Nirenberg stated that it was important to work together to improve services and outcomes and thanked everyone for their work.

Councilmember Sandoval moved to adopt the Ordinance for Item 20. Councilmember Treviño seconded the motion. The motion to approve prevailed by the following vote:

Leo Gomez, President and CEO of Brooks Development Authority, spoke in support of the Brooks Area Regional Center Plan. He spoke of their work in the process and stated that he looked forward to implementation.

Councilmember Viagran stated that she was pleased that the Brooks Area Regional Plan was the first of the SA Tomorrow Plans to be completed. She stated that implementing the goals and strategies of the Brooks Area Regional Plan will ensure a higher quality of life for the future. She submitted letters of support from the Brooks Development Authority, Highland Hills Neighborhood Association, East Central Independent School District, VIA Metropolitan Transit, and San Antonio River Authority.

Councilmembers Sandoval, Courage, Saldaña, and Treviño expressed their congratulations and support.

Mayor Nirenberg stated that the manifestation of many years of work on the SA Tomorrow Plan had not been easy. He noted that implementing the Brooks Center first illustrated the great amount of growth on the Southside.

Councilmember Viagran moved to adopt the Ordinance for Item 22. Councilmember Courage seconded the motion. The motion to approve prevailed by the following vote:

24. City Manager's Report

2019 VOLUNTEER INCOME TAX ASSISTANCE PROGRAM

City Manager Walsh provided an update on the Volunteer Income Tax Assistance Program (VITA). He stated that the VITA Program was an IRS-Sponsored Program run locally by a partnership of more than 30 organizations including the Department of Human Services, Catholic Charities, and the United Way. He reported that between February 4th and April 15th; the Coalition operated 20 VITA Sites across the community including one mobile site. He noted that the VITA Program filed over 30,000 tax returns securing \$42.7 million in total refunds and \$16.5 million in earned income tax credits to the community. He thanked the many volunteers, staff, and organizations that helped make the program a reality.

Melissa Ramirez presented Item Z-2 and stated that staff and the Zoning Commission recommended approval. She reported that of 33 notices mailed; none were returned in favor and 26 received in opposition. She added that the Dignowity Hill Neighborhood Association was in support of an amended request of 3 units. She stated that the request would require 9 votes for approval due to the opposition exceeding 20%. She noted that the applicant was amending their request to 3 units.

Mayor Nirenberg recognized Patrick Christensen. Mr. Christensen stated that he was representing the applicant and they were reducing their request to 3 units. He read the following statement into the record: 1) Only three single family homes will be built on the lot; 2) Will keep the 8-foot fire lane; 3) The structure closest to Hackberry will mirror the height of approximately 35 feet of the neighboring house at 315 Hackberry and will have a maximum square footage of 1,900 or smaller; 4) The two back structures will have a maximum height of 26 feet and will have a maximum square footage of 1,700 or smaller; 5) The observation decks will remain under the second story rooflines; and 6) The new design will be resubmitted to and approved by HDRC.

Mayor Nirenberg called upon the citizens registered to speak.

Joseph Garcia stated that he was speaking on behalf of the residents that had expressed opposition to the original request and they were supportive of the amendments and criteria agreed to by the applicant.

Cullen Jones, Secretary of the Dignowity Hill Neighborhood Association, stated that they were in support of the request as amended by the applicant.

Councilmember Hall stated that he had worked with the Neighborhood Association, Property Owner, and Developer to come to an agreement.

Councilmember Hall moved to approve Item Z-2 with the conditions stated by Mr. Christensen. Councilmember Treviño seconded the motion. The motion to approve with conditions prevailed by the following vote:
