The City Council convened in a Regular Meeting on Thursday, May 9, 2019 at 9 am. City Clerk Leticia Vacek took the Roll Call noting a quorum with the following Councilmembers present:

- 2. Mayor Nirenberg led the Pledge of Allegiance to the Flag of the United States of America.
- 3. Approval of Minutes of the City Council Regular Meetings of April 10 11, 2019

Councilmember Sandoval highlighted the donations from the Southwest Texas Regional Advisory Council for Trauma (STRAC) and thanked staff for applying for the grants (Items 8, 9, and 10).

Councilmember Viagran highlighted the amendments to the Mission Del Lago Tax Increment Reinvestment Zone (TIRZ) Development Agreement and thanked everyone that worked on the project (Item 13).

Mayor Nirenberg and Councilmember Saldaña recused themselves from voting on Item 6 by exiting the Council Chambers and noting they submitted their recusal forms to the City Clerk.

Councilmember Treviño moved to adopt the Ordinance for Item 6. Councilmember Courage seconded the motion. The motion to approve prevailed by the following vote:

Councilmember Perry asked that Items 7 and 14 be addressed jointly as both are under the direction of Deputy City Manager Peter Zanoni and this would be his last City Council Meeting. He presented Mr. Zanoni a hat to wear in Corpus Christi as their new City Manager.

City Clerk Vacek read the captions for Items 7 and 14:

14. Resolution of No Objection for the Echo East Apartments I, LLC application to the Texas Department of Housing and Community Affairs Non-Competitive 4% Housing Tax Credits program for the construction of Echo East, a 211-unit multi-family rental housing development, located at 301 Spriggsdale Avenue in City Council District 2. [Peter Zanoni, Deputy City Manager; Verónica R. Soto, Director, Neighborhood and Housing Services]

Councilmember Hall requested a presentation on Item 14. Veronica Soto stated that staff

recommended approval of a Resolution of No Objection for the Echo East Development. She outlined the project details and noted that the Low Income Housing Tax Credits of 4% were Non-Competitive. She indicated that all 211 Units would serve families with an Average Median Income of 60% and below. Councilmember Hall confirmed that the City Council was only approving the Resolution of No Objection for the project and asked if the project agreement would have to be updated. Erik Walsh replied that they had been in contact with the developer and the agreement would have to be amended. Councilmember Hall recognized Barbara Gervin-Hawkins. Ms. Gervin-Hawkins thanked the City Council for their support and noted that the only changes to the Agreement would be to include the affordable housing component and a change in the developer. Councilmember Hall expressed support for the project.

Councilmember Viagran asked of next steps. Peter Zanoni replied that staff would present amendments to the agreement within the next few weeks.

Councilmember Pelaez asked of the changes. Ms. Gervin-Hawkins replied that they had changed the project to include an affordability component based on the needs of the community. Councilmember Pelaez expressed concern with the timing and stated that he had additional questions on the project.

Councilmember Gonzales stated that she has seen many projects change due to various reasons and expressed her support for the project.

Councilmember Sandoval asked of the current agreement. Mr. Zanoni replied that it would have to be modified based on the new type of development. He noted that an agreement existed due to the fact that the city was giving 10 acres of the project to the developer. Councilmember Sandoval asked why the Resolution of No Objection was being approved prior to revising the agreement. Mr. Zanoni replied that it was based on the project need to secure funding. Ken Sachs, Attorney for the Echo East Project, stated that it was due to their requirements for financing. Councilmember Sandoval stated that she was pleased that they were incorporating an affordable housing component but concerned with the timing and agreement.

Councilmember Saldaña asked of the sentiment of the community regarding the project. Ms. Gervin-Hawkins replied that they were very supportive of the project as the property had been vacant for 40 years. She added that she would continue to keep the community involved throughout the project.

Councilmember Treviño highlighted the design elements of the project and expressed his support. Councilmember Perry stated that he looked forward to the project completion due to the mixed-use component that would be a great addition to the area.

Councilmember Perry moved to adopt the Ordinances for Items 7 and 14. Councilmember Courage seconded the motion. The motion to approve Items 7 and 14 prevailed by the following vote:

16. City Manager's Report

City Manager Walsh recognized Deputy City Manager Peter Zanoni who would be leaving the City of San Antonio to become the City Manager in Corpus Christi. He stated that Mr. lived in San Antonio for serving multiple 22 years Mayors, Councilmembers, and the community at large. He noted that for the past nine years, Mr. Zanoni had served as Deputy City Manager and Assistant City Manager. He mentioned many of Mr. Zanoni's accomplishments to include implementation of the City's Pre-K 4 SA totaling the 2017-2022 Bond Program \$850 million Infrastructure Improvements. He stated that Mr. Zanoni was a great asset to the City of San Antonio and would be greatly missed. Mayor Nirenberg and the City Councilmembers thanked Mr. Zanoni for his great work for the City of San Antonio and wished him well in his new role as City Manager of Corpus Christi. Mr. Zanoni thanked everyone for the recognition and support.
