The City Council convened in a Regular Meeting. City Clerk Leticia M. Vacek took the Roll Call noting a quorum with the following Councilmembers present:

- 2. Mayor Ron Nirenberg led the Pledge of Allegiance to the Flag of the United States of America.

Councilmember Treviño moved to approve the Minutes of the City Council Regular Meetings of June 19-20, 2019. Councilmember Courage seconded the motion. The motion to approve prevailed by the following vote:

She is pursuing a degree in Broadcasting and Communications. Ms. Tidwell founded Cinderella's Closet which takes gently used formal gowns and donates them to young women in need.

Mayor Nirenberg called upon Jack M. Finger to speak.

Jack M. Finger spoke in opposition of Item 12 related to the Citywide Bike Project. He stated that bike lanes would cause vehicle traffic jams. He also spoke in opposition of Item 22 approving a Special Improvement District in the ETJ.

Councilmember Treviño highlighted Item 18 and thanked Ms. Sara Olivares whom served as Zoning Commissioner. He congratulated her for her service to the Zoning Commission. INDIVIDUAL ITEM

City Clerk Vacek read the Resolution in its entirety for Item 4:

2019-08-15-0050R

4. Resolution calling for action by the Texas Legislature and United States Congress to address gun violence; and for the City of San Antonio to review available actions and policies at the local level to enhance the safety of San Antonio residents. [Andy Segovia, City Attorney]

Mayor Nirenberg called upon State Representative Roland Gutierrez to speak.

State Representative Roland Gutierrez thanked the City Council for their leadership addressing Gun Violence. He asked the Governor and other State Legislators to call a Special Session to discuss gun violence. He stated that recently; he learned that an individual you can have an AR-15 or AK-47 at age 15, but must be 21 to buy a handgun. He added that he was not trying to take guns away; he just wants a common sense solution such as a gun buy-back and gun lock safety program.

Paul Ruiz, Founder of Alamo Area Democracy Project Dedicated to Ignite the Vote spoke in support of the Resolution. He expressed his support against gun violence and support for sensible gun control laws. He recognized the Council for being at the forefront of fighting discrimination. He stated that the attack on El Paso was an attack on us all and called for an end to gun violence.

Velma Ybarra Member of the Planning Committee of the Institute on Mexican American History of Civil Rights' member of LULAC 4383 of San Antonio; spoke in support of the Resolution. She called for a repeal of current gun laws and thanked City Council for bringing forth the Resolution.

Dr. Gloria Rodriguez expressed her support of the Resolution and thanked the Council for their leadership role for action to address gun violence. She stated that there have been 250 mass shootings in this country and that no other country comes close to having massive killings than that in the United States.

Jack M. Finger spoke in opposition of the Resolution. He stated that when tragedy occurs people want to change laws but changing laws would not prevent criminals from gun violence.

Mayor Nirenberg called out Sandy Hook, Virginia Tech, Parkland, El Paso, Columbine, Gilroy, Sutherland Springs, Dayton, Virginia Beach, Orlando, San Bernardino, and Aurora; stating that he could

go on but needed no written or spoken context to understand the gravity of the situation. Mayor Nirenberg asked the Council to stand in solidarity and urged State and Federal Officials to pass common sense gun legislation. He called on all governments to assist in protecting our community.

Councilmember Viagran stated that this was a somber moment and at the same time; a moment of hope and one of action for all today. She explained that it took the City Clerk Vacek six minutes and 41 seconds to read the Resolution. She explained that in Dayton Ohio; it took 32 seconds to injure 26 people. She stated that the Federal and State Government needed to initiate a gun buyback program and advocate for background checks and ban the sale of military style weapons.

Councilmember Gonzales stated that she has been trying to understand the issues of gun violence in this country as it relates to racism and people of color. She stated that gun violence was a part of our culture that needed to change. She praised Mayor Nirenberg and Council colleagues for initiating the Resolution and to State Representative Gutierrez for trying to change laws to end gun violence.

Councilmember Pelaez stated that the new Jansport Backpack that is level three bulletproof costs \$209 and the less expensive version costs \$154. He stated that these backpacks are on the market for children and that was obscene; but necessary in these days of gun violence. Councilmember Pelaez stated that the Resolution calls for the Governor of Texas, and our Federal Government to have the difficult conversation of gun violence.

Councilmember Treviño stated that everybody connects with the pain of a gun violence story that has affected us. He recognized Mayor Nirenberg for the Resolution calling for action to address gun violence. He stated that thoughts and prayers ceased to be a strategy for gun violence and called for common sense policy.

Councilmember Rocha Garcia explained that according to the Gifford's Law Center six out of ten of the deadliest mass shootings occurred within the last year where 1,500 children were killed. She cited Article 1, Section 3 of the City Charter "it is our duty to cooperate to accomplish any lawful purpose for the interest, welfare, health, morals, comfort, and safety of our residents." She stated that the proposed Resolution as written does exactly what the City Charter calls for; to advocate for the safety and welfare of our residents.

Councilmember Perry stated that violence does not have a place in our society. He explained that we have many laws on the books to protect the public, however; there are elements in society that disregard laws. Councilmember Perry expressed appreciation to State Representative Gutierrez' common sense approach to curb gun violence. He expressed support for calling on the State and Federal Government to come up with solutions to end gun violence and protect the people.

Councilmember Cabello Havrda expressed support for the Resolution to show solidarity with the victims. She implored the public not to normalize gun violence. She stated that all are all affected by gun violence. She urged people not to get caught up in the emotion but to stand up against gun violence.

Mayor Nirenberg stated that he was extremely proud of his Council Colleagues and recognized there different perspectives and backgrounds. He stated that gun violence was a volatile subject to tackle; but the Council has come together in unity to show solidarity to talk about gun violence. He stated that the passage of the Resolution signifies a commitment to action.

Councilmember Viagran moved to approve the Resolution. Councilmember Courage seconded the

motion. The motion to approve prevailed by the following vote:

AYES: Mayor Nirenberg, Treviño, Andrews-Sullivan, Viagran, Rocha Garcia, Gonzales, Cabello Havrda, Sandoval, Pelaez, Courage, and Perry.

Razi Hosseini, Interim Director of TCI provided a presentation of the Applewhite Project. He described

the project scope and timeline which begins construction September 2019 and is scheduled to be completed March 2020.

Councilmember Viagran thanked Mr. Hosseini and explained the project was part of the voter approved Bond Project. She also described the proposal was funded by partnership with Avanzar and was intended to alleviate traffic congestion.

Councilmember Gonzales highlighted the project and explained that the City was managing the project and no City funds were being used.

CITY MANAGER'S REPORT

23. City Manager's Report

City Manager Erik Walsh reported that the Fire Department established the first ever unique camp held over two weekends, July 20th and July 27th. He stated that Councilmember Rocha Garcia attended the camp designed for girls between ages 14 to 18. He explained that several women firefighters participated in a litany of activities and encouraged over 50 participants to explore the Firefighting career field.

City Manager Walsh recognized David McCary, Director of Solid Waste Management for being awarded a National Award by the Solid Waste Association of North America for Best in Safety Innovation Award. He explained that accidents were reduced by 47% and injuries reduced by 50% which resulted in a 28% reduction of lost workdays. City Manager Walsh thanked Mr. McCary and the Solid Waste team for practicing safety and getting the job done in an efficient manner.

City Manager Walsh recognized Chris Callanen and congratulated him on his retirement after working for the City over 25 years. Mr. Walsh stated that Mr. Callanen had a stalwart presence and a knack of being able to balance his workload and of City Councilmembers. A round of applause and standing ovation ensued as well as congratulatory comments were made by the City Council.
