**ROLL CALL**

The City Council convened in a Regular Meeting. City Clerk Leticia M. Vacek took the Roll Call noting a quorum with the following Councilmembers present:

1. The Invocation was delivered by Archbishop Gustavo Garcia-Siller San Fernando Cathedral, guest of Councilmember Ana Sandoval, District 7.
2. Mayor Nirenberg led the Pledge of Allegiance to the Flag of the United States of America.

**POINT OF PERSONAL PRIVILEGE**

Mayor Nirenberg read a Proclamation in honor of Tony Parker, former San Antonio Spurs player and the 28<sup>th</sup> Pick of the 2001 NBA Draft. He noted that Tony Parker was one of the quickest Point Guards in the League. Mayor Nirenberg proclaimed November 9 to be Tony Parker Day and extended sincere appreciation for all that Tony Parker has accomplished for San Antonio. Mayor Nirenberg invited the Spurs Coyote to the podium and encouraged everyone to show their spirit on Saturday by wearing their Tony Parker Spurs Jerseys on game day. A standing ovation ensued for Tony Parker.

Councilmember Perry announced that Veteran's Day would be recognized on Monday, November 11, 2019. He recognized all the Veterans that have contributed to the defense of our nation and of our freedom. He added that freedom was not free and that many Veterans have contributed to our freedom.

Councilmember Perry invited the public to attend the Veteran's Day Parade and participate in all the activities to be held in honor of Veteran's Day.

Councilmember Perry announced that District 10 was celebrating Native American Heritage Month this weekend and invited the public to attend the festivities. He invited Vance Blackfox to the podium to explain the celebration. Mr. Blackfox noted that he was a citizen of the Cherokee Nation and invited the public to Comanche Lookout Park in celebration of Native Heritage Month. He added that the land was originally the lands of the Tonkawa People and that it was important to celebrate the Indigenous People across the lands. He noted that the celebration was in recognition of diversity, tolerance, and acceptance of all people.

Councilmember Pelaez recognized Veteran Dr. William Elizondo whom served the Marines in 1951 and was in combat in Korea. Councilmember Pelaez wished the Marines Happy Birthday and welcomed Dr. Elizondo to the City Council Chambers.

Councilmember Treviño welcomed Dr. Elizondo and invited the public to celebrate Veteran's Day on Saturday and reminded all of the Veteran's Day Parade on Houston Street and a special lunch was planned in partnership with the VFW Post 76 from 1-3 pm on Saturday as well.

Councilmember Andrews-Sullivan recognized all the Veterans that have served their Country and those whom continue to serve. She invited the public to attend District 2 first Family Reunion and experience the positive parts of District 2 as they unite for fellowship and give back to the community. She invited the public to adopt a tree and enjoy food from Mr. and Mrs. Tony G's.

Councilmember Sandoval thanked Dr. Elizondo for his service.

Mayor Nirenberg recognized Shameka Hudson for all she does with the San Antonio Spurs.

Mayor Nirenberg highlighted grants funds approved for the CivTech Division Pilot Program within Geekdom's Broader Incubator Program. City Clerk Vacek read the caption for Item 15.

Ordinance approving the submission of a grant application and acceptance upon award of up to \$100,000.00, for the Bill and Melinda Gates Foundation “Voices for Economic Opportunity Challenge” to raise the awareness and understanding of poverty. [Colleen M. Bridger, MPH, PhD, Assistant City Manager; Melody Woosley, Director, Human Services]

Councilmember Gonzales asked what the expected result of the grant was. Ms. Woosley reported that Human Services was working on the Poverty Report and discovered the grant opportunity during that process. Ms. Woosley added that the Gates Foundation was seeking applicants to come up with innovative creative ideas to raise the level of the conversation around poverty locally in their communities. Ms. Woosley noted that the Human Services Department was requesting approval to submit the grant application that was due November 13, 2019.

City Manager Walsh reported that the \$100,000 grant would provide flexibility because the grant funds do not provide limits on the conversation of poverty. He added that allows Human Services to come up with innovative ideas to take advantage of this opportunity.

Councilmember Courage commended Human Services Staff for pursuing grant funding. He added that a portion of the research determine what was the actual cost-of-living for people who live in San Antonio and how much does it cost for a family of four not to be in poverty.

Mayor Nirenberg recalled the report provided by Dr. Drennon last term before the budget process began. He recalled Dr. Bridger’s statement regarding the single most investment of education to create opportunities for socioeconomic mobility. He added that would be instructive to come back to the data that Dr. Drennon reported and do a recalibration utilizing equity principles.

Councilmember Gonzales suggested that discussions of poverty be conducted like summit hearings instead on panel meetings. She added that could include areas of impact such as through workforce, community health, planning, and transportation all from a poverty perspective.



Councilmember Sandoval noted that she planned on utilizing Councilmember Gonzales suggestion in early 2020 to have hearings in District 7 on topics relevant to community health and equity.

Councilmember Viagran noted that poverty was not something new and that they have discussed economic segregation, economic mobility, and economic opportunities for years. She encouraged Council Colleagues to attend the NLC Session entitled Real Panel and Discussion. She added that the Session provided information, history, and background for all cities in the United States and the impact on San Antonio.

Councilmember Andrews-Sullivan noted that poverty be considered from a humanitarian standpoint. She added that all constituents deserve the right to live and have a sustainable living source for generations to come.

Councilmember Gonzales moved to approve the Item 15. Councilmember Sandoval seconded the motion. The motion prevailed by the following:

Ms. Verónica Soto provided a brief presentation regarding the Verano Tax Increment Reinvestment Zone (TIRZ) located in South San Antonio and included the Texas A&M University and Campus. She noted that the Tax Increment generated was reimbursed to the developer. She added that the developer planned to build over 5,000 single-family and multi-family units over 3,000 acres in this TIRZ. She reported that the developer also planned a 2 million square feet of retail commercial and industrial space. Ms. Soto added that the assignment to SouthStar would begin the first phase in alignment and focus on housing for families at 60% AMI up to 120% AMI. She noted that the result would be a mixed community with mixed incomes and affordable housing. She reported that the name Verano was proposed to change to Vida San Antonio and if approved, construction was scheduled to begin after the New Year with units on the ground in 2021.

Councilmember Viagran reported that the project began in 2007 and remained stagnant until 2016 when changes were made. She noted that the TIRZ Board Members were not active but has since been revitalized in 2019. She added that Texas A&M San Antonio was part of the SA Tomorrow Regional Centers and meeting have begun with students at Texas A&M and the community.

Thad Rutherford, SouthStar CEO thanked the Mayor and Council for their consideration of the proposed Vida San Antonio Project. He noted that it has been a long time coming but it was the right time with the right team and the right plan. He thanked Lori Houston, Verónica Soto, Mike Shannon, and their

staff for working on this project and District 3 and District 4 staff. He also thanked the Verano Land Group and their ownership, Joe De Simone for keeping it together through the recession.

Councilmember Rocha Garcia commended Dr. Matson from Texas A&M San Antonio for staying the course and building the campus. She added that the fact that 6,500 students enrolled at A&M San Antonio was a testament to her leadership and stewardship. Councilmember Rocha Garcia thanked Councilmember Viagran for her leadership and partnership.
