ROLL CALL

The City Council convened in a Regular Meeting. Deputy City Clerk Tina J. Flores took the Roll Call noting a quorum with the following Councilmembers present:

1. The Invocation was delivered by Peter Onofre, guest of Councilmember Rocha Garcia, District 4.
2. Mayor Nirenberg led the Pledge of Allegiance to the Flag of the United States of America.
3. Approval of Minutes of the City Council Regular Meeting of January 30, 2020, City Council Special Meeting of January 30, 2020, City Council Special Meeting of February 10, 2020, and City Council Regular Meeting of February 12, 2020.

Councilmember Andrews-Sullivan moved to approve the Regular City Council Meeting Minutes of January 30, 2020, City Council Special Meeting of January 30, 2020, City Council Special Meeting of February 10, 2020, and City Council Regular Meeting of February 12, 2020. Councilmember Treviño seconded the motion. The motion prevailed by the following vote:

POINT OF PERSONAL PRIVILEGE

Mayor Nirenberg recognized Deena Kilpatrick from the San Antonio Fire Department for her work with SAFD Personnel to ensure their fitness. He proclaimed March 2020 as National Athletic Training Month.

Ms. Kilpatrick stated that the theme of National Athletic Training Month was that Athletic Trainers impact healthcare through action. She noted that Athletic Trainers work in collaboration with Physicians to provide quality healthcare through prevention, injury evaluation, treatment, and rehabilitation for musculoskeletal injuries in various settings across the nation.

Councilmember Viagran congratulated Ms. Kilpatrick for her work.

Dr. Taylor Eighmy introduced UTSA's new head football coach Jeff Traylor.

Mr. Traylor thanked the Mayor, City Council, and Erik Walsh for their hospitality. He expressed his appreciation for use of the Alamodome and the upgrades which have been completed. He stated that UTSA's spring game would be held on April 18, 2020 and he invited the Mayor and City Council to be recognized there.

Councilmember Peláez welcomed Mr. Traylor to San Antonio.

Councilmember Perry congratulated Mr. Traylor and wished him good luck.

Councilmember Treviño welcomed Mr. Traylor to San Antonio.

Councilmember Rocha Garcia welcomed Mr. Traylor to San Antonio.

Councilmember Courage stated that having a football team at UTSA contributed to the community.

Councilmember Cabello Havrda welcomed Mr. Traylor to San Antonio and thanked him for joining the team.

Councilmember Andrews-Sullivan stated that she was excited to have the team playing in Council District 2.

Councilmember Viagran welcomed Mr. Traylor to San Antonio.

Mayor Nirenberg thanked Mr. Traylor for being a good leader and stated that he looked forward to observing his success on the field.

CONSENT AGENDA

Item 17 was pulled for Individual Consideration.

Mayor Nirenberg called upon the individuals registered to speak.

Elizabeth Kertesz spoke in support of Item 22 and stated that a Property Assessed Clean Energy (PACE) Program would assist building owners to execute cash flow positive financially feasible projects which would improve the City's existing building stock, reduce energy consumption, and save money for tenants on operating expenses while addressing the climate and energy crisis.

David Matiella stated that the PACE Program was synonymous with a long-term future of sustainability for lowering San Antonio's carbon footprint. He noted that buildings played a big role in terms of the sustainable future of San Antonio and the PACE Program was a great funding mechanism and tool to achieve better building stock.

Jack M. Finger spoke in opposition to Item 18 and its fiscal impact on businesses. He spoke in opposition to Item 20D.

Councilmember Viagran highlighted Item 12 and the PACE Program. She thanked the Alamo Area Council of Governments (AACOG) for partnering with the City on the PACE Program.

Councilmember Sandoval highlighted the Council District 7 residents who were being appointed or reappointed to boards and commissions. She highlighted Item 22 and stated that the PACE Program was one of the first measures implemented from the Climate Action and Adaptation Plan (CAAP).

Diane Rath stated that the Request for Proposals (RFP) for the PACE Program had been drafted and would be released today or tomorrow. She noted that AACOG was anticipating a partnership with the City.

Councilmember Perry highlighted Item 11 which was a project to fund an engineering study of Salado Creek which ran through Lady Bird Johnson Park from the Tobin Trailhead through McAllister Park. He noted that the engineering study would identify damage and corrective measures.

Councilmember Peláez highlighted Item 18 and noted that the San Antonio Restaurant Association, the San Antonio Hotel and Lodging Association, and the Real Estate Council were enthusiastically supportive of the item.

Councilmember Treviño expressed support for the PACE Program.

Councilmember Andrews-Sullivan highlighted Nicole Garcia who would be the Council District 2 appointee to the San Antonio Youth Commission and highlighted the Inner City TIRZ Board for adding value to the improvements of Maverick Plaza and La Villita.

Councilmember Cabello Havrda thanked Elizabeth Kertesz for her work on climate change. She highlighted Item 13 which would bring improvements such as lighting, Little League fields, and a pavilion with picnic tables to Cuellar Park. She congratulated the Edgewood Pony League which was the only San Antonio team to compete in the Pony Baseball League's Bronco 11 World Series last summer.

Mayor Nirenberg congratulated Razi Hosseini, David McCary, and Tina Flores on their new appointments.

SAPD Chief McManus stated that the grant, if awarded, would begin on October 1, 2020 and would include funding for up to 25 new Police Officers devoted to domestic violence prevention. He noted that the Police Officers would be assigned to Crisis Response Teams (CRT) Operations at each substation. He reported that the amount of the award was \$12.8 million and would include a cash match of \$9 million. He noted that the San Antonio Police Department (SAPD) would be required to retain the Police Officers for a minimum of 12 months following grant expiration. He added that the grant period was three years.

Councilmember Viagran asked how the Budget was augmented to retain the Police Officer positions funded. Erik Walsh replied that the first year match of \$1.6 million would be set aside in FY 2021 to augment the Police Officers funded.

Councilmember Cabello Havrda thanked Chief McManus and Maria Villagómez for their efforts and leadership on the grant.

Councilmember Gonzales asked if there was the potential to redirect the funds to programs. Mr. Walsh replied that the grant would only fund uniformed Officers. He added that there may be funding sources or grant opportunities for alternative preventive programs.

Councilmember Viagran moved to approved Item 17. Councilmember Andrews-Sullivan seconded the motion. The motion prevailed by the following vote:

CITY MANAGER'S REPORT

- 25.** City Manager's Report

Mr. Walsh stated that March 8, 2020 was International Women's Day which celebrates the achievements of women and a call for action to accelerate Women's equality. He noted that over 47% of the City's civilian workforce was female. He stated that this year would mark the fifth year of the Women's Leadership Mentoring Program and since it began 184 employees had participated in the Program. He added that he encouraged graduates of the program to recruit at least two individuals to apply the following year. He highlighted the work of the City's female

employees and played a video. He announced that on March 13-14, 2020, the City's first Girls Empowerment Summit would be held with over 15 community partners and 60 mentors participating.

Councilmember Rocha Garcia noted that the response to the Summit was positive and she thanked everyone for their support.

Mr. Walsh noted that the program was popular and would continue to grow. He recognized the promotions of David McCary, Razi Hosseini, Homer Garcia, and David Newman. He thanked Art Reinhardt for his contribution to the organization. He reminded everyone that General Ayala was on loan (50%) to the Hispanic Chamber of Commerce for the next 60 days as Interim Chief Executive Officer.

Councilmember Viagran noted that this month and this year was the 100th anniversary of the ratification of the 19th Amendment where women earned the right to vote.

Mayor Nirenberg recognized City Attorney, Andy Segovia on the occasion of his birthday.
