The City Council convened in a Regular Meeting. Acting City Clerk Tina J. Flores took the Roll Call noting a quorum with the following Councilmembers present:

- 2. Mayor Nirenberg led the Pledge of Allegiance to the Flag of the United States of America.
- **3.** Approval of Minutes of the City Council Regular Meeting of February 13, 2020.

Councilmember Andrews-Sullivan moved to approve the Regular City Council Meeting Minutes of February 13, 2020. Councilmember Treviño seconded the motion. The motion prevailed by the following vote:

Mayor Nirenberg observed a Moment of Silence in recognition of Edward Ramos and his family. He stated that Mr. Ramos was a 24-year veteran of the Parks and Recreation Department.

Mayor Nirenberg called upon Jack M Finger whom was registered to speak.

Jack M. Finger spoke in opposition of Item 15 as it funded the performing arts. He spoke in opposition to Item 18 which would fund out-of-town projects. He spoke in opposition to Items 21 regarding the Violence Prevention Program as well as Items 22-25 regarding affordable housing.

ITEMS FOR INDIVIDUAL CONSIDERATION

Acting City Clerk Flores read the caption for Item 5 and the Supplemental Posting Language.

5. Ordinance extending the declaration of public health emergency issued on Friday March 13, 2020 by Mayor Ron Nirenberg to continue active preparedness for COVID 19 contingencies.

Supplemental posting language added to the Agenda.

Ordinance extending the Declaration of Public Health Emergency issued on Wednesday, March 18, 2020 by Mayor Ron Nirenberg until 11:59 pm on Sunday, April 19, 2020 to continue active preparedness and response for COVID-19 contingencies; authorizing the City Manager to take actions related to the public health emergency; and declaring other regulations related to the COVID-19 virus. City Manager Walsh stated that he authorized the closure of City Facilities including Libraries, Senior Centers, City-Owned Galleries & Museums, and Pre-K 4 SA Centers. He noted that Presiding Judge Obledo made adjustments to the Municipal Court schedule and Juvenile Court mediations and aligned jury trials with actions at the Bexar County Courthouse.

City Manager Walsh stated that all city-hosted events and city-related business travel had been cancelled and that he authorized department directors to utilize remote work policies for employees who had the ability to do so; or had child care issues due to the closure of schools and daycare centers. He noted that all employees returning from international travel had been directed to self-quarantine for 14 days and those which could not work remotely were placed on paid administrative leave. City Manager Walsh stated that he would direct departments to make similar adjustments based on domestic travel for employees if returning from a hot spot. He reported that employees had been redeployed to other departments according to need and that he was meeting with key staff members twice daily to determine challenges and areas for improvement.

Colleen Bridger reviewed a map of states reporting cases of COVID-19 to the Centers for Disease Control (CDC) and noted that the data was delayed by two days. She stated that the data for Bexar County was updated last night and reported that there were 25 positive tests for COVID-19 of which eight were travel related; four were from close contact; and 13 were under investigation. She noted that community spread was defined as the spread of an illness for which the source of infection was unknown and that no community spread cases had been reported. She noted that the highest percentage of cases were observed from individuals between the ages of 40-49 with 58% male and 42% female.

Dr. Bridger stated that 388 individuals had been quarantined at Lackland Air Force Base (LAFB) with 124 individuals remaining and three at the Texas Center for Infectious Disease (TCID). She provided an overview of the pre-approved testing which was performed to date and added that individuals with symptoms and had a physician referral could be tested. Dr. Bridger noted that the City had partnered with the Department of Human Services (DHS) to implement a process which assisted individuals who did not have a primary care provider, health insurance, or could not afford to go to an urgent care clinic. She provided examples of some of the ways that the community could help and noted that the information was also available on the City's website.

Deputy City Manager Maria Villagómez stated that City Departments had implemented COVID-19 emergency response protocols since February 6, 2020 with the City spending and committing \$1.6 million. She reported that the City had spent \$675,000 and committed \$925,000 since March 13, 2020 with a majority of the expenses funding personnel, the San Antonio Fire Department (SAFD), Metro Health, medical staff contracts, and supplies. Ms. Villagómez noted that the City would seek reimbursement from the Federal Government for these expenses. She added that the City was notified of a \$1 million grant from the Department of State Health Services (DHS) which would be utilized to reimburse Metro Health for expenses incurred.

Ms. Villagómez stated that measures taken to slow the spread of COVID-19 had created a global economic disruption which made it difficult to estimate the impact to the City. She noted that

measures implemented would further create a slowdown in the economy and could potentially result in a global recession. Ms. Villagómez reported that the San Antonio International Airport received approximately 10 million passengers per year, or approximately 30,000 per day, and that the number of passengers had decreased by 69%. She noted that the annual revenue for the Airport was \$105 million and that \$44 million of this amount had been collected as of the end of February 2020. She stated that revenues for airport parking were 67% lower in the month of March compared to 2019 and sales for airport concessions had decreased by 45%.

Ms. Villagómez reported that 28 out of 49 events scheduled to be held at the Convention Center between March 4, 2020 and October 4, 2020 had been cancelled or postponed and had collected \$8 million in revenue for the year out of the anticipated \$21 million. She noted that 10 out of 31 events to be held between March and September 2020 at the Alamodome had been cancelled or postponed and had collected \$5 million in revenue out of the anticipated \$12.7 million.

Ms. Villagómez stated that the Hotel Occupancy Tax (HOT) rate was 16.75% with 9% being collected by the City. She reported that the City had projected collecting a total of \$96 for the Fiscal Year but had only collected \$36 million through the end of February. Ms. Villagómez noted that many hotels were reporting occupancy rates of less 10% with some considering suspending services.

Ms. Villagómez highlighted the Parking Fund and reported a decrease in Downtown parking. She noted that the City anticipated a 50% reduction in parking occupancy by the end of the week. She stated that total parking revenues collected for the year totaled \$11.3 million with \$9.2 million coming from Downtown parking garages, lots, and meters

City Attorney Andy Segovia stated that the main objective of the 4th Emergency Order issued by the Mayor was to limit the spread of COVID-19 and included measures that would protect the ability of public and private healthcare providers to handle the influx of patients as well as safeguard public health and safety. He noted that the World Health Organization (WHO) declared COVID-19 as a pandemic which resulted in the Mayor implementing safeguards that who mitigate its spread through the community. Mr. Segovia stated that the 4th Emergency Order that went into effect at midnight last night outlined the following three specific restrictions:

- 1. No gatherings of 50 individuals or more with the exception of:
 - San Antonio International Airport
 - Public or private schools
 - Child care facilities
 - Places of worship
 - Funeral homes
 - Museums
 - Bus stops
 - Office space, hotels, and residential buildings
 - Grocery stores, shopping malls, and outdoor markets
 - Hospitals, medical facilities, and shelters

- Jails and detention centers
- 2. No in-area dining at restaurants
- 3. Closure of the following non-essential businesses:
 - Bars
 - Lounges
 - Nightclubs
 - Taverns
 - Private clubs
 - Gyms or health studios
 - Indoor commercial amusement businesses
 - Bowling alleys
 - Bingo parlors
 - Theaters

Mr. Segovia noted that the Emergency Order also required testing data to be reported daily to Metro Health. As it relates to the Ordinance, he reported that the Ordinance to be considered would extend the Emergency Order for an additional 30 days as well as provided the City Manager with additional flexibility to address the COVID-19 crisis to include closing gathering spaces, modifying rules and regulations, and suspending provisions that could interfere with the essential operations of the City and with responding to the emergency. Mr. Segovia noted that violations of the Ordinance or the Emergency Order were Class C Misdemeanors and were punishable by a fine up to \$2,000.

City Manager Walsh stated that staff was focused on response and recovery efforts while continuing to provide the community with services. He noted that staff was sharing ideas with the Cities of Austin and Dallas and determining how to take advantage of Federal Legislation. He stated that the Financial Forecast Schedule needed to be revised as sufficient financial data would not be available by the time the report was to be presented on April 15, 2020.

Mayor Nirenberg stated that the City's goal was to protect the health and safety of the community and the City's future.

Mayor Nirenberg called upon the individuals registered to speak.

Dawn Ann Larios with the San Antonio Restaurant Association asked that the City Council think about all of the individuals who had been negatively impacted by the closure of restaurants when considering the extension of the Emergency Order.

Patrick Costello stated that extending the Emergency Order by 30 days would be detrimental to the education of culinary students and the future workforce. He asked that the City Council consider extending the Emergency Order a day or week at a time and not a month at a time.

Casey Covington spoke of the financial impact to restaurant employees who have lost their jobs. He stated that restaurants were one of the safest places in the city.

Gary Johnson stated that restaurants emphasized sanitation and safety. He suggested that the Emergency Order be extended a week at a time.

Jimmy Hasslocher requested that the City Council work with the business community and review the closure of businesses on a weekly basis.

Ms. Larios urged the City Council to patronize local food establishments and text her pictures of their food.

Jack M. Finger spoke of the lack of information on the number of individuals who had recovered from COVID-19.

Councilmember Sandoval asked about the payment of tickets at Municipal Court. Mr. Segovia replied that a review of Municipal Court operations was being conducted but details were not available. Councilmember Sandoval asked of the protocols being implemented to ensure that City facilities were clean and sanitized for the safety of employees. Mr. McCary highlighted the measures taken by the City at City buildings, especially those still open. Councilmember Sandoval asked why the City was proposing the extension of the Emergency Order by 30 days instead of a week or two. Mr. Walsh replied that the extension of 30 days was recommended by staff but could be revised by the City Council. He noted that it was important to provide guidance, direction, and advice to businesses and the community. Dr. Bridger added that the extension by 30 days would slowdown the possibility of the virus spreading through the community.

Councilmember Treviño asked of protocols established to protect the homeless. Dr. Bridger stated that the University Health System had partnered with CentroMed to ensure that standards for infection control were in place at Haven for Hope and highlighted measures enacted to mitigate the spread of COVID-19. Councilmember Treviño requested that staff ensure that vulnerable populations were provided with appropriate resources, that existing resources be utilized to assist small businesses, and that 3-1-1 services be expanded. He continued by requesting that the City Council be briefed on how Hurricane response efforts would impact COVID-19 response and recovery efforts. Councilmember Treviño reported on Bexar Appraisal District challenges encountered to include the payment of taxes, assessing property values, and certifying tax rolls. He recommended that the City as well as the State consider rolling back property taxes in light of COVID-19.

Mayor Nirenberg emphasized the ability of the Mayor and the City Council to rescind the Emergency Declaration at any time.

Councilmember Peláez asked for recommendations on the abatement of non-essential fees incurred by businesses. Mr. Walsh stated that he could not recommend those adjustments until the financial impact of COVID-19 to the City was known. Councilmember Peláez requested that the City Attorney brief the Council on whether the City had business interruption insurance coverage. He asked if the Emergency Order provisions were extended to other local municipalities. Mr. Walsh clarified that the Emergency Order did not extend to other local municipalities.

Councilmember Peláez asked if a doctor's note was needed in order to get tested. Dr. Bridger stated that the Primary Care Physician would be required to call a designated number on behalf of the patient to secure a test date, time, and location. Councilmember Peláez requested that the City Attorney's research whether the City was allowed to restrict physicians from performing elective surgeries and could implement policies restricting Pay Day lenders from imposing predatory practices.

Councilmember Andrews-Sullivan suggested colleges and universities in the City allow students to graduate even though they could not complete their internships and extenships due to COVID-19. She also recommended partnering rideshare companies with restaurants which did not have drive-thru, curbside, or delivery services; that the City ensure that families were not displaced or evicted; that the City suspend the meal tax; and that the City establish a fund to mitigate the economic impact on restaurants. Councilmember Andrews-Sullivan requested information on how COVID-19 could affect those with lupus, leukemia, and cancer. Dawn Emerick stated that communication with providers was the best way for individuals to determine the impact of the COVID-19 virus on their health. Councilmember Andrews-Sullivan asked of the impact the Emergency Order would have on faith-based organizations. It was reported that the organization was required to follow social distancing protocols. Councilmember Andrews-Sullivan asked if drive-thru testing would be extended to ride-share service providers. Ms. Villagómez stated that staff would evaluate drive-thru testing for ride-share service providers and report to the City Council.

Councilmember Andrews-Sullivan asked of communication efforts undertaken to target the City's youth. Dr. Emerick reported that the City had been targeting vulnerable populations to include seniors but data reflected that individuals between 20-29 were the most vulnerable. She stated that the City would be disseminating information to families in order to ensure that everyone received the message.

Councilmember Cabello Havrda asked if the City provided a list of resources to businesses and employers. Jeff Coyle replied that the COVID-19 link on the City's homepage contained information for businesses such as SBA loans from the Federal Government and the Lyft Fund as well as resources for unemployed individuals. He stated that the Economic Development Department sent an email to several thousand businesses and business associations which listed available resources. Councilmember Cabello Havrda asked of precautions implemented by Animal Care Services. Mr. Walsh highlighted protocols implemented and reported that adoption services were still being offered. Councilmember Cabello Havrda asked if Emergency Responders have adequate supplies of protective equipment. It was reported that the Police Department did not have a shortage of equipment as supplies not being used by City Departments had been reassigned to them.

Councilmember Rocha Garcia asked if information would be redirected to the 20-29 age group utilizing social media. Mr. Coyle replied that currently information was directed to the general public and the 20-29 age group had not been specifically targeted. Councilmember Rocha Garcia asked about the City's website. Mr. Coyle stated that the information available on the website was general and that if individuals had questions about their symptoms they needed to

contact their provider. Councilmember Rocha Garcia spoke on the CCR that she submitted which recommended that the City expand eligibility requirement for rental mortgage assistance and emergency assistance programs as the demand for these services would increase over the next few months.

Councilmember Courage asked about the number of tests the City could administer on a daily basis. Dr. Emerick reported that the City could administer 200 tests daily and was coordinating with the State Office of Emergency Management to get additional tests kits. Councilmember Courage asked about the safety of going outside. Dr. Emerick stated that it was safe and recommended that individuals adhere to social distancing regulations and washed their hands regularly.

Councilmember Courage asked if restaurants could maintain health standards as mandated by the Centers for Disease Control (CDC) and local regulations if restaurant were allowed to remain open under certain guidelines. Ms. Larios replied that restaurants were taking extra precautions and sanitizing everything. She noted that since the Coronavirus was identified, restaurants had been utilizing throw away items such as utensils and paper menus. Councilmember Courage made an amendment to the current motion adding the phrase "and requiring the City Council to meet every week or additionally as needed to re-evaluate the Declaration to receive information and to approve policy changes required by the COVID-19 emergency". Mr. Segovia stated that the City Council could extend the Emergency Order but could not amend it. Mr. Walsh stated that Thursday Council Meetings would continue, including on the fourth week of the month. At the request of Councilmember Courage, Mayor Nirenberg stated that he concurred with the recommendation made by City Manager Walsh.

Mayor Nirenberg asked staff for details on the Governor's declaration issued today. Carlos Contreras reported that the Governor had issued a declaration which did not allow gatherings of greater than 10 individuals, no eating at restaurants, and no drinking in bars. He noted that gyms and schools were also closed and visitation at nursing homes would not be allowed except in critical care situations. He added that the Governor's declaration would be effective starting at midnight today through April 3, 2020.

Mayor Nirenberg asked of the jurisdictional bounds of the City's Ordinance. Mr. Segovia stated that the City's Ordinance could be more restrictive than the Governor's declaration but not less restrictive. Mayor Nirenberg asked if the only material impact to the City's Ordinance was making the mandatory 10-person gathering an enforced restriction as opposed to the Centers for Disease Control (CDC) recommendation. Mr. Segovia replied that it was. Mayor Nirenberg clarified that public gatherings would be restricted to 10 individuals or less until April 3, 2020 or at such time that the Emergency Order was modified beyond April 3, 2020.

Councilmember Perry spoke on the CCR submitted by Councilmember Rocha Garcia and recommended that the City not change any funding policies until there was a better understanding of the impact to the Budget. He requested that additional meetings of the City Council be held. Councilmember Perry stated that he was opposed to extending the Emergency Order by 30 days and was in favor of extending it for two weeks. He asked if an amendment to the Ordinance could be made to the length of time that the Emergency Order. Mr. Segovia

replied that the Emergency Order could not be amended but the duration could.

Councilmember Viagran asked if there were any discussions at the State level regarding Pay Day lending and the possible use of predatory actions to the unemployed. Mr. Coyle replied that the Governor had addressed predatory practices in general but not on Pay Day lending. Councilmember Viagran asked if any discussions regarding relief for restaurants had taken place at the State level. Mr. Coyle replied that it had not. Councilmember Viagran asked for the number of part-time City employees. Ms. Villagómez replied that she would provide the number of full and part-time City employees to the City Council.

Councilmember Viagran asked about resources provided to part-time City employees who did not have health insurance. Ms. Villagómez stated that she would need to coordinate with Human Resources to obtain the requested information. Councilmember Viagran asked if any changes would be made to Contracts and the RFP process. Ms. Villagómez stated that the Council would be provided information on Contract Revenue and Expenditure Contracts at a later time. Councilmember Viagran asked about the impact on construction companies and procedures to ensure that they pulled the necessary permits. Mr. Walsh reported that there was a decrease in customers going to Development Services but continued to operate.

Councilmember Sandoval expressed support for the 30 day time frame as long as the City Council reviewed the status of the Emergency Order every week as well as the CCR submitted by Councilmember Rocha Garcia. She spoke on the importance of meeting frequently to discuss response efforts as well as addressing recovery efforts now.

Councilmember Gonzales asked of the status of the VITA Program. Mr. Walsh stated that VITA Program sites had been closed. Dr. Bridger added that staff partnered with 2-1-1 to create an online version so that the public could still utilize the services of the VITA Program and that staff continued to process tax forms. Ms. Villagómez commented that the deadline to file taxes had been extended but remained April 15th for those that owed taxes. Councilmember Gonzales voiced her concern with extending the deadline by 30 days as many businesses would close. She asked about communication efforts utilized by the City to information local businesses of COVID-19 protocols. Mr. Coyle provided examples of how the City was providing information to businesses such as making Robo-calls, sending emails, making announcements on social media, and posting information to the City's website. He stated that Tele Town Hall meetings and podcasts could also be used as communication tools. Ms. Villagómez spoke on the availability of WIFI at parks and noted that Staff was discussing expanding the coverage area.

Mayor Nirenberg noted that the State would be distributing information on unemployment benefits.

Councilmember Courage confirmed that his motion was to reduce the time frame to two weeks and would end on April 3, 2020.

Councilmember Perry moved to change the emergency declaration from 30 days to 14 days ending on April 3, 2020. Councilmember Courage seconded the motion. The motion failed by the following vote:

- **AYE:** 3 Gonzales, Courage, and Perry.
- NAY: 8 Mayor Nirenberg, Treviño, Andrews-Sullivan, Viagran, Rocha Garcia, Cabello Havrda, Sandoval, and Peláez.

Councilmember Sandoval moved to approve Item 5. Councilmember Andrews-Sullivan seconded the motion. The motion prevailed by the following vote:
