The City Council convened in a Regular Meeting. City Clerk Tina J. Flores took the Roll Call noting a quorum with the following Councilmembers present:

1. The Invocation was delivered by Reverend Kevin L. Nelson of the Calvary Baptist Church, guest of Councilmember Andrews-Sullivan, Council District 2.
2. Mayor Nirenberg led the Pledge of Allegiance to the Flag of the United States of America.
3. Approval of Minutes from the City Council Meetings of August 6, 2020, August 11, 2020, and August 12, 2020.

Councilmember Andrews-Sullivan moved to approve the Minutes. Councilmember Courage seconded the motion. The motion prevailed by the following vote:

Mayor Nirenberg noted his appreciation to all those in attendance who observed social distancing guidelines as the pandemic continues. He stated that plexiglass dividers were utilized by City Councilmembers on the dais and some of the seating for the public was unavailable to ensure social distancing guidelines were met. He thanked all those in attendance for their cooperation.

POINT OF PERSONAL PRIVILEGE

Councilmember Rocha Garcia spoke about Rett Syndrome which was a neurological disorder which was seen almost exclusively in females. She noted that a family affected by Rhett Syndrome contacted her office and asked for help to bring awareness of the syndrome. She added that Rett Syndrome had multiple effects such as speech loss, seizures, scoliosis, and irregular breathing patterns. She stated that many girls and women lose the ability to walk and require maximum assistance with daily activities. She recognized Genevieve Isabella whom had been affected by the syndrome and her grandparents who continue to be inspired by her resilience and joyfulness.

POINT OF PERSONAL PRIVILEGE

Mayor Nirenberg recognized Suzanne Scott with the San Antonio River Authority (SARA) in her new role as Texas State Director for the Texas Nature Conservancy after 13 years with SARA. He stated that Ms. Scott was appointed General Manager of SARA in 2007 and directed SARA's programs and projects, managed the agency's budget, oversaw and worked with staff, Engineers, Scientists, Environmental Managers, field crews, and a host of other professionals to extend SARA's environmental leadership, stewardship, expertise, and to broaden appreciation for the San Antonio River and its ecosystem. He thanked Ms. Scott on behalf of the City, for her stewardship and leadership and noted that he looked forward to a partnership with the Texas Nature Conservancy.

Suzanne Scott stated that she was proud of everything she accomplished with SARA and looked forward to the opportunities with the Texas Nature Conservancy to address environmental issues statewide.

Councilmember Sandoval congratulated Ms. Scott and wished her well and thanked her for her accomplishments with SARA.

Councilmember Courage thanked Ms. Scott for her accomplishments in San Antonio, the State of Texas and with other Countries.

Councilmember Viagran recognized Ms. Scott and her team for their dedication and commitment to SARA. She recognized Ms. Scott for the work she accomplished with San Pedro Creek, Mission Reach, the Creekway System in San Antonio, and the ecosystem. .

ITEMS FOR INDIVIDUAL CONSIDERATION

City Clerk Flores read the caption for Item 32.

Ordinance amending Chapter 5 entitled "Animals" and Chapter 20 entitled "Municipal Court" of the City Code to regulate the retail sale of pets, expand eligibility for the animal care compliance assistance account, provide updates consistent with the strategic priorities of Animal Care Services, and establish penalties. [David McCary, Assistant City Manager; Heber Lefgren, Director, Animal Care Services]

Hebert Lefgren recognized the Animal Care Services Advisory Board members present. He

stated that Animal Care Services (ACS) committed to study the restriction of retail sales of dogs and cats during Budget development in FY 2019. He noted that in 2019 ACS issued surveys and presented the findings with its FY 2020 Budget presentation. He indicated that over 380 cities restricted the retail sale of dogs and cats, and the largest animal welfare organizations in the country supported more aggressive restrictions on the retail establishments due to the widely accepted breeding practices of wholesale breeders, otherwise known as puppy mills.

Mr. Lefgren reported that three of the 51 pet stores in San Antonio sold dogs and cats as part of their local business model and most puppies sold originated from out-of-state breeders. He indicated that many of the stores that sold dogs and cats were licensed by the United States Department of Agriculture (USDA) whose standards were below San Antonio standards.

Mr. Lefgren stated that cities across the nation had banned or restricted retail pet sales for over a decade with three legislative models having survived legal scrutiny. He indicated that retail pet sale regulations did not impact direct-to-consumer sale of pets, and enforcing the humane treatment of pets housed in pet stores was separate from the proposed Ordinance. He noted that the intent of the Ordinance was to separate the City from the inhumane treatment of animals bred commercially for wholesale use.

Mr. Lefgren reported that the following three models have remained unchallenged for municipalities:

1. Option 1-Allow sales with no pet source restrictions
2. Option 2-Prohibit all sales
3. Option 3-Allows sales but restrict pet sources to shelters, rescues, and animal control agencies

Mr. Lefgren stated that regulating puppy breeders was the role of the State and Federal Governments; however, a community had the right to say that pet sourcing was important and the City would not support puppy mill sales.

Mr. Lefgren reported that the amendment was introduced as part of the FY 2019 Budget process and in July 2019, the SASpeakUp survey was released. He indicated that traditional media (news and print), paid media, digital media, and City email distribution lists and in-person events were utilized to provide information to the Community. He noted that the ACS Board and the Community Health and Equity Committee were briefed in November and December 2019, respectively and again in May and September 2020, respectively.

Mr. Lefgren stated that the proposed code changes regarding pet sales included the following retail dog and cat sales restrictions:

- Must be sourced from a shelter, animal control agency, or licensed rescue organization
- Must be sterilized, microchipped, immunized, free of parasites, and come with documentation

Mr. Lefgren reported that the minimum fines for all pet sales offenses would be raised from \$100

to \$500 for first time offenses, and the seller's permit violations would require sterilization of all pets located at the place of sale. He added that sellers' permits were only for residents selling pets out of their primary residences.

Mr. Lefgren stated that an Animal Care Compliance Assistance Account was established in FY 2018 which would provide resources to assist residents in compliance with Chapter 5 amendments and expanding eligibility by no longer:

- Requiring residents to already be in compliance with microchip and vaccination requirements
- Limiting improvements to property/premises

Mr. Lefgren reported that other proposed code changes included:

- Establishing a 30-day timeline for compliance with dangerous dog regulations
- Restrictions on "nuisance" feeding of animals
- Clarifying when an Animal Rescue Organization needed a license
- Grammatical improvements

Mr. Lefgren stated that if approved, the changes to Chapter 5 of the City Code would be effective January 1, 2021, and the retail pet store requirements would go into effect on July 1, 2021.

PUBLIC COMMENT

WRITTEN TESTIMONY

Public Comments have been submitted through the eComment system and are attached to the minutes.

City Clerk Tina Flores announced that written testimony was received from Kayla Kerr, of Puppyland, H. Analco Gonzalez, and the Pet Industry Joint Advisory Council in opposition to Item 32. She stated that written testimony was received from the Animal Policy Group requesting changes to the proposed amendments.

Mayor Nirenberg called upon the individuals registered to speak.

Laura Zamora stated that Pet Land was not in competition with shelters and rescue organizations and did not support or utilize puppy mills. She noted that the proposed changes did not address the issue of puppy mills.

Julianne Marchbanks stated that there was no shortage of dogs and puppies in San Antonio and she questioned Pet Land's need for a lobbyist.

Liz Catalan spoke of a dog that was previously used for breeding in a puppy mill and noted that there was no place for puppy mills in San Antonio.

Albert Sardinias stated that prohibiting pet stores from only selling animals from rescues would not address San Antonio's stray animal problem.

Paula Sardinias indicated that the proposed changes would not reduce the number of unwanted and abandoned pets in the City.

Jaime Trueba stated that the proposed changes would have a negative impact on consumer choice, employees, businesses, and pets.

David Moreno stated that the proposed changes would not affect bad breeders but would affect businesses, employees, and a citizen's right to choose where they would get their pet.

Jamie Stewart indicated that individuals had the right to choose what pet to buy and where they bought it from and taking an individual's rights away in any situation was wrong.

Justin Kerr stated that during the COVID-19 Pandemic when businesses were struggling day-to-day, San Antonio was forcing small family-owned businesses to close.

Kayla Kerr indicated that the proposed changes would put the community at risk.

Olivia Travieso stated that the proposed changes made no distinction between good and bad breeders. She indicated that Pet Land worked with national breeding experts to identify the best facilities for their pets.

Anita Fernandez spoke on behalf of a local Veterinarian who stated that it was a mistake to think that all dog breeders had no regard for the adult dogs and puppies they sold.

Analco Gonzalez stated that Petland represented a sector of the community that there was a need for and were willing to work with the sector that the proposed changes were attempting to address. He requested more time for discussions.

Sandra Nutting stated that individuals in the rescue and shelter community were frustrated with the lack of responsibility of owners and the lack of enforcement of laws and regulations regarding spaying, neutering, and abuse.

Katie Jarl stated that the proposed changes would drive the pet market towards more humane sources and would encourage pet stores to become part of the pet overpopulation solution.

Rita Brautigian expressed support for the proposed changes and stated that the City could and would extend the same level of compassion and concern for pets inhumanely bred in other states and transported to San Antonio.

Stacy Sutton Kerby reported that puppies that come from large-scale breeders were vulnerable to disease and defect an

Abigail Real spoke in support of the proposed changes and noted that the City could not control its stray and unwanted dog population. She stated that as a result, the local shelter had to euthanize perfectly healthy dogs due to overpopulation.

Lucy Sanchez spoke of the treatment of puppies at Pet Land when she worked there and expressed support for the proposed changes.

Catherine McKey stated that the City Council should approve the proposed changes, enforce regulations, and address the stray population.

Frank Burney expressed support for the proposed changes and noted that Pet Land could adopt the business model of promoting adoptions.

Allison Goddard stated that unfortunately many puppies that came from pet stores were sick with parvo, distemper, and many other health issues.

Susan Henry stated that puppy mills did not perform any genetic testing on their dogs and did not spay or neuter them which would lead to congenital health issues.

Mayor Nirenberg reported that 243 written comments were received in support of the proposed changes and 54 written comments were received against the proposed changes. Councilmember Sandoval asked if there were ethical concerns related to the USDA certification. Mr. Lefgren stated that the minimum USDA did not reflect the values of the City. Councilmember Sandoval expressed support for the proposed changes to Chapter 5 of the City Code.

Councilmember Rocha Garcia asked how many pet stores and their employees would be affected by the proposed changes. Mr. Lefgren replied that three pet stores would be impacted in the City. He added that he did not have information on the number of employees affected.

Councilmember Andrews-Sullivan asked who individuals should call to report unethical practices of breeders. Mr. Lefgren replied that individuals could call 3-1-1 to report such issues.

Councilmember Viagran asked if the proposed changes would stop the sale of pure bred dogs. Mr. Lefgren stated that those with a breeder's or seller's permit would continue to be able to conduct business.

Councilmember Sandoval moved to approve Item 32 as presented by Staff. Councilmember Andrews-Sullivan seconded the motion.

The motion prevailed by the following vote:

AYE: 9 - Mayor Nirenberg, Treviño, Andrews-Sullivan, Viagran, Cabello Havrda, Sandoval, Pelaez, Courage, and Perry

NAY: 1 - Gonzales

ABSENT: 1 - Rocha Garcia

Councilmember Courage asked if Petco and PetSmart sold dogs and cats. Mr. Lefgren stated that they did not but they did provide a space for rescue agencies to independently operate in that space. Councilmember Courage asked how many stores provided space on a regular basis. Mr. Lefgren reported that there may be 15-20 stores that provide space on a regular basis.

Councilmember Gonzales asked if any of the stores that sold pets had violated any regulations. Mr. Lefgren stated that one of the three stores in San Antonio was new and the others did not have any violations. He noted that the Ordinance did not address the care of animals in San Antonio. Councilmember Gonzales indicated that she did not support the proposed changes.

Councilmember Pelaez expressed support for the proposed changes.

Councilmember Perry stated that the proposed changes did not support the ACS mission. He asked if the pet stores could pick from a list of acceptable breeders. City Attorney Andy Segovia replied that the City could not decide who pet stores could and couldn't do business with. Mr. Lefgren noted that staff proposed this change because the industry outside of Texas was difficult to regulate.

Councilmember Treviño stated that he supported the proposed amendments and noted that ACS performed extensive research on the policy.

Councilmember Cabello Havrda stated that her constituents expressed support for the proposed amendments and she supported the Ordinance.

Councilmember Andrews-Sullivan requested a report of application approvals and denials by geographic areas.

Councilmember Perry expressed concern regarding some leading questions on the SASpeakUp Survey.

Mayor Nirenberg stated that the greatness of a nation and its moral progress could be judged by the way it treats its animals. He noted that he was pleased to support the proposed amendments with an effective date of January 1, 2021.

Councilmember Viagran moved to amend the effective date to January 1, 2021 for all amendments. Councilmember Sandoval seconded the motion. The motion prevailed by the following vote:
