# REPORT OF THE LIBRARY DIRECTOR

Library Director Ramiro S. Salazar reported meeting with Councilwoman Gonzales on September 23, 2020 regarding the Memorial Branch Library Bond Project and plans for a virtual community input meeting.

Mr. Salazar reported that McCreless Branch Library will serve as a voting site for November 2020 Election and that the renovation project will be postponed until after the November 2020 Election. Mr. Salazar also reported that in October, Library Staff will bring the new dates for the McCreless Branch renovation dates to the Board for action. Mr. Salazar acknowledged the Library Team for all their hard work.

Mr. Salazar reported that the City of San Antonio is moving to Phase 3 of the City's Return to Work plan. The Library's Phase 3 of reopening includes:

- Expanding Public Computer Appointments to all library locations
- Expand Contact Free Pick-up Hours at locations serving as Computer Appointments to standardize hours across the system
- Issuance of Enhanced Library Card (photo on library card) by appointment (date TBD) at the for LEARN at SAPL sites (Carver, Westfall, Bazan and Johnston Branch Libraries)

He also noted the Library is taking into consideration serving as voting sites while planning for the Phase 3. Additionally, Mr. Salazar stated playgrounds, walking trails and adult fitness stations located on library properties are now open. Related to this, the Parks and Recreation Department is working to remove the barriers erected earlier in the year. He reported the playground at the Landa Branch Library would remain closed due to damage found on the anchor posts which poses a safety issue.

Assistant Library Director Kathy Donellan provided update on adopted Fiscal Year 2021 Budget. She referenced the electronic message sent to the Library Board of Trustees regarding the adopted budget and stated the San Antonio City Council adopted the Fiscal Year 2021 City of San Antonio budget on September 17, 2020. The adopted budget is consistent with City Manager's proposed budget for the Library. She stated the Library's approved budget does not include any reductions related to library service cuts for FY 2021. Additionally, the City has instituted a hiring freeze, lowered employee medical premiums by 10% and has not laid-off any staff members. She noted the youth fine free policy will continue in Fiscal Year 20201 and there is an additional \$150,000 to the Library's base budget for contractual price increases in the operating budget. Ms. Donellan reported receiving gap funding for the McCreless and Forest Hills Branch Library Bond Projects. She also stated the

## **San Antonio Public Library Foundation**

Amy Hone, Executive Director for the San Antonio Public Library Foundation reported on the Virtual Board of Directors meeting and the no show gala "Catrina No Ball at All". Ms. Hone reported that 100 grants were submitted in 2020 which resulted in \$250,000 in cash gifts and \$128,000 in in-kind gifts. She provided an update on the endowments held by the Library Foundation. Library Director Ramiro Salazar commended Ms. Hone and the Library Foundation Team for their work to support the Library. Board Chair Paul Stahl thanked Ms. Hone and the Foundation.

## Friends of the San Antonio Public Library

Beth Graham, President of the Friends of the San Antonio Public Library, reported on Friends Board meeting. Ms. Graham also reported on reduced fundraising, major cuts in revenue, and revised 2020 budget. Therefore, the Friends of the Library Board voted to revise the 2020 budget whereby reducing the gift allocation to the Library by \$12,100 to \$37,900. Ms. Graham reported on a \$5,000 grant challenge from anonymous donor that will kick off the membership drive which will continue thru December 31, 2020. Ms. Graham also reported that the Arts & Letter Award ceremony will be conducted this year using yard signs, filming video, and presenting a gift box to recipients.
