SAN ANTONIO PUBLIC LIBRARY MINUTES OF THE MEETING OF THE BOARD OF TRUSTEES October 28, 2020

The San Antonio Public Library Board of Trustees met in regular session on Wednesday October 28, 2020 at 4:30 p.m. in a videoconference, San Antonio, TX. The meeting was called to order at 4:38 p.m. by Paul Stahl, Chair.

Board Chair Paul Stahl asked the Trustees to observe a few moments of silence to bring their attention to the work before them this evening and keep healthcare workers in their thoughts.

APPROVAL OF MINUTES

Board Chair Paul Stahl brought forth the meeting minutes for September 23, 2020 for consideration. Trustee Marcie Ince moved to approve the minutes. Trustee Jean Brady seconded the motion. A roll call vote was conducted. Trustees JoAnn Harris and Josie Uriegas Martinez were not present at this time. None opposed the motion. The motion passed.

CHAIR'S REPORT

Board Chair Paul Stahl reported that Ms. Sydney Knowles was nominated by District 6 Councilwoman Havarda to serve on the Library Board of Trustees. Ms. Knowles is expected to be appointed during the November 12, 2020 City Council Meeting. Mr. Stahl expressed his gratitude to Lora Eckler for her thirteen (13) years of service on the Library Board and looking forward to celebrating tenure on the Library Board when inperson meetings resume due to the COVID-19 emergency.

TRUSTEES REPORT

Trustee Jean Brady reported receiving on an email from League of Women Voters commending San Antonio Public Library Staff for serving as voting sites and providing information.

Trustee Juspreet Kaur expressed her excitement for a new Trustee being appointed to represent District 6. Ms. Kaur also recognized Lora Eckler for her contributions to the Board and noted she learned a lot from Trustee Eckler.

REPORT OF THE LIBRARY DIRECTOR

Library Director Ramiro S. Salazar reported that on November 4, 2020 the Library will roll out Phase 3 of the City of San Antonio's Back to Work services which includes:

- Public Computer Reservations at all locations (except Forest Hills and McCreless because of renovation projects)
- Standardized hours for Contact Free Pickup at all locations
- Enhanced Library Card available at Learn at SAPL sites (Westfall, Bazan, Carver and Johnston Branch Libraries)

Mr. Salazar also reported the Library is serving as a voting site for the General Election on November 3, 2020:

- 19 library locations as sites during Early Voting
- 21 library locations as sites for Election Day
- So far, over 222,000 votes cast at library locations (45% total votes)

Mr. Salazar reported on request from City's Office of Emergency Management to identify three or four libraries to serve as 'response centers' sites after any possible active threat event.

Mr. Salazar announced the passing of Irma Nicolas. The Cortez Branch Library is named in honor of Mrs. Nicolas' last father, Raul A. Cortez who was a Spanish language radio pioneer. Mrs. Nicolas' son, Guillermo, is a former Chair of the San Antonio Public Library Foundation.

Mr. Salazar responded to questions from Library Trustees.

BUDGET REPORT

Gabriella Rauschuber, Department Fiscal Administrator, delivered the Library's budget report covering the month of September 2020. She reported fiscal year 2020 ended on September 30 and the "unaudited report" shows the Library ending the year with a 2% budget balance. Ms. Rauschuber reported savings due to civilian hiring freeze and slowdown in spending due to Library locations being closed during Phase 2. Ms. Rauschuber also reported the reduction of the gift from the Friends of San Antonio Public Library is reflected in the report.

COMMITTEE REPORTS

Executive Committee

Board Chair Paul Stahl reported that in his absence Trustee Juspreet Kaur lead the Executive Committee met on Tuesday, October 20, 2020. The Committee met to set the agenda for the October 2020 Board Meeting.

Budget Committee

Committee Chair Juspreet Kaur, reported that the Budget Committee did not meet this reporting period.

Facilities Committee

On behalf of Facilities Committee Chair Andrea Sanchez, Project Control Manager Rich Walker reported on the Facilities Committee meeting on October 21, 2020. Mr. Walker delivered a presentation on Capital Improvement Projects for Forest Hills Branch Library, Encino Branch Library Playground, and Schaefer Branch Library Trail Project. Mr. Walker also reported on current status of Library Bond Projects. Mr. Walker added that there will be several action items later in the agenda. The next Committee meeting is on November 12, 2020.

Naming Committee

Board Chair Paul Stahl reported that the Naming Committee met on October 13, 2020 and there is an action item later in the agenda.

Public Relations Committee

Committee Chair Jean Brady reported that the Public Relations Committee did not meet this reporting period.

Friends of the San Antonio Public Library

Beth Graham, President of the Friends of the San Antonio Public Library, reported on Friends of the Library Board meeting. Ms. Graham also reported receiving \$3,900 matching donation with still a month to go to reach \$5,000 grant challenge from anonymous donor. She is also working to set up the Friends of SAPL Facebook account to accept donations.

San Antonio Public Library Foundation

Amy Hone, Executive Director for the San Antonio Public Library Foundation reported on good news as a result of votes at the last Foundation Executive Committee Board Meeting:

- Five (5) Library projects were selected for additional funding in the amount of \$274,000
- The annual endowment gift is \$247,000 for 2021.
