The City Council convened in a Regular Meeting. City Clerk Tina J. Flores took the Roll Call noting a quorum with the following Councilmembers present:

1. The Invocation was delivered by Reverend Dr. Jessica Kemp, guest of Mayor Nirenberg.
2. Mayor Nirenberg led the Pledge of Allegiance to the Flag of the United States of America.
3. Approval of Minutes from the City Council Meetings of May 13, 2021 and May 19, 2021.

Councilmember Courage moved to approve the Minutes of May 13, 2021 and May 19, 2021.
Councilmember Cabello Havrda seconded the motion. The motion prevailed by the following vote:

POINT OF PERSONAL PRIVILEGE

Mayor Nirenberg recognized Jesse Kuykendall, known locally as Chef Kirk, who had won the Championship of the Food Network's show Chopped that aired on May 25, 2021. He noted that Chef Kirk was the first classically trained San Antonio chef to take home the prize and expressed the City's pride of her accomplishment. Mayor Nirenberg presented Chef Kirk with a Citation recognizing her

winning the Chopped Championship. Chef Kirk thanked the Mayor and City Council for this recognition and noted that San Antonio was a culinary melting pot of Mexican cuisines and other cultures.

POINT OF PERSONAL PRIVILEGE

Mayor Nirenberg noted that June 18, 2021 was the first time in the City's history that there would be an official City holiday to recognize Juneteenth which honored a key milestone in our Nation's History. He invited all to celebrate the contributions African Americans made to the City to include those of Kerry Clack who was awarded the honor of Star Opinion Writer of the Year.

Deborah Omowale, Executive Director, San Antonio African American Community Archive & Museum, spoke of the history of African American enslavement and the Emancipation Proclamation impact to the Nation. She noted that the rich heritage of San Antonio should include the heritage, culture and stories of the African American community and thanked the City Council for their recognition of Juneteenth as an official holiday.

Councilmember Cabello Havrda noted that just days prior, the United States Congress had passed a vote to make Juneteenth a National holiday.

Councilmember Viagran encouraged all to visit the San Antonio African American Community Archive and Museum which depicted the history of how San Antonio had worked toward equity for all.

Councilmember Pelaez noted the importance of recognizing Juneteenth as a National holiday which recognized justice and goodness for all.

Councilmember McKee-Rodriguez thanked Ms. Omowale for sharing the history associated with Juneteenth and noted that this history should be shared in school curriculums.

POINT OF PERSONAL PRIVILEGE

Mayor Nirenberg welcomed the Court of King Antonio and stated that San Antonio residents greatly anticipated participating in the upcoming Fiesta activities. He noted that the Texas Cavaliers Association had honored the memory of the Alamo heroes and kept alive the spirit of Texas history and the part San Antonio played in that history. He recognized Phil Bakke for being chosen as King Antonio 98 and for his many contributions to the Texas Cavaliers organization and mission. Mayor Nirenberg presented a proclamation to King Antonio and his Court.

Mr. Bakke thanked the Mayor and City Council for recognizing the King Antonio Court and invited all to attend the Texas Cavaliers River Parade on June 21, 2021. He reiterated that the City of San Antonio was ready to celebrate Fiesta again and thanked the City and Texas Cavalier Officials for navigating the challenges of the past year. He recognized the students who were selected as Art Contest winners and stated that each Council District was presented with the artwork of the students in their Districts.

Councilmember Rocha Garcia thanked the Texas Cavaliers for their continued educational support of children in the San Antonio community. She recognized the youth that had won the Artwork competition and noted the relevant subject matter that her district artwork student winner depicted which highlighted healthcare workers efforts during the COVID-19 Pandemic.

Councilmember Viagran applauded the charitable work of King Antonio and his Court and recognized the student artwork winners.

Councilmember Courage thanked King Antonio and his Court for their service to the community. He recognized Tatyana Esperanza and Sergei Ramos who were selected as Council District 9 Artwork Contest winners.

Councilmember Perry recognized the Council District 10 Artwork Contest winner from District 10.

Councilmember McKee-Rodriguez recognized the District 2 Artwork Contest winners and noted that the past year had been a challenging year for students and teachers. He encouraged students to continue to create and express themselves through the arts.

Mayor Nirenberg recognized each of the Artwork Contest student winners individually and stated that there were over 2,000 submissions to the contest this year.

CONSENT AGENDA ITEMS

Mayor Nirenberg announced that Items 4, 7, P-1, Z-1, Z-2, Z-3, Z-6, P-3, Z-8, P-4, Z-10, Z-11, and Z-12 were pulled for Individual Consideration. He added that Item Z-15 was postponed by applicant and would not be considered.

Mayor Nirenberg called on the individuals registered to speak on the Consent Agenda.

Jack M. Finger spoke in opposition of Items 28G and 35.

Monica Shultz spoke in support of Item Z-14.

Councilmember Pelaez highlighted Item Z-14 and stated that the proposed multi-family housing project would be of great benefited to the blighted area. He thanked the project developers for their determination in bringing the project and related public improvements to the area. He highlighted Item 18 which approved the construction of Dan Markson Park that would include playscape designs for special needs children. He noted that the late Mr. Markson would be proud to have his name associated with the park since he had dedicated his life to accessibility issues and giving vulnerable people affordable housing options.

Councilmember Sandoval highlighted Item 41 which approved a water quality demonstration project under the Edwards Aquifer Protection Project. She noted that the project would research different filtration methods for keeping the Aquifer's water clean by keeping oil, grease, and other contaminants out of the ecosystem.

Councilmember Viagran highlighted Item 16 which approved upgrades to Animal Care Services facilities and associated services. She highlighted Item 23 which approved an affordable housing pilot program in District 2.

Councilmember Courage highlighted Item 28G that approved the appointment of Marco Barros to the Zoning Commission. He highlighted Items 37 and 38 which approved the designation of the Somerset Grove and the Valley Sol Tax Increment Reinvestment Zones (TIRZ). He asked that a closer evaluation be completed on the length of time a TIRZ was in place on future proposed TIRZ projects.

Councilmember Perry spoke in support of Item 18 that approved the construction of Dan Markson Park with accessibility playscape designs. He noted that these types of park facilities and Morgan's Wonderland supported the inclusion of children with special accessibility needs.

Mayor Nirenberg acknowledged his appointment of Julissa Carielo to the Small Business Advisory Commission.

Councilmember Sandoval moved to approve the remaining Consent Agenda Items. Councilmember Courage seconded the motion. The motion prevailed by the following vote:

City Clerk Flores read the caption for Item 4.

Mayor Nirenberg called on the individuals registered to speak on Item 4.

Jack M. Finger spoke in opposition of the use of COVID-19 Recovery and Resiliency Funds to be used for agreements for dedicated hotels to be used for homeless shelters.

City Manager Erik Walsh introduced Item 4 which upon approval would allow staff to accept COVID-19 related funds associated with the Recovery & Resiliency Plan and American Rescue Plan Act (ARPA) totaling approximately \$35.5 million. He stated that if approved, an agreement for a low-barrier hotel shelter to include clinical and epidemiology support services provided by SAMMinistries would move forward. City Manager Walsh added that the accepted funding would be used towards

such efforts as: 1) Emergency Housing Assistance Program, 2) Rental Housing Assistance Program, 3) Extension of contracts with various agencies for case investigation and contact tracing, and 4) Programs to support community health workers, school based mental health programs, domestic violence counseling and behavioral risk factor surveillance.

Veronica Carrillo, COVID-19 Executive Officer, provided a briefing on the proposed usage of accepted funds from the Recovery & Resiliency Plan and American Rescue Plan Act (ARPA).

Ms. Carrillo reviewed the activities associated with the acceptance of \$35.5 million in CARES & CRRSA grants:

- Authorized/Extended agreements for:
 - Homeless low-barrier emergency shelter
 - Clinical and epidemiology support
 - COVID-19 surveillance/data analysis
 - Emergency rental assistance with Bexar County

Ms. Carrillo reviewed the activities associated with the acceptance of \$302.1 million in ARPA grants:

- Authorized/Extended contracts for:
 - University of Texas Health Science Center at Houston – Case investigation and contract tracing
 - University of Texas Health Science Center at San Antonio – Dr. Barbara Taylor
 - Referral to community health worker hub
 - School-based mental health programs
 - Domestic violence counseling
 - Behavioral Risk Factor Surveillance System

Ms. Carrillo noted that CARES and CRSSA grant awards supported programs in the area of vaccines, health programs, housing mortgage assistance, airport operations assistance, Head Start Programs, and childcare services.

Ms. Carrillo reviewed Budget statuses associated by program and accepted funding categories:

Ms. Carrillo noted that the proposed low-barrier homeless emergency shelter would serve as a Pilot Program for 12 months which provided homeless individuals alternatives to living in encampments. She stated that a \$1.17 million lease agreement with Days Inn Riverwalk would provide 49 rooms to homeless individuals and added that a \$1.73 million agreement for facility operations would be entered with SAMMinistries.

Ms. Carrillo reviewed Health Implementation Plan Agreements which would cover temporary staffing

for clinical support, Epidemiologist services, and variant sequencing and data analysis. She noted that the \$1.2 million in funding would be required for these services and added that an additional \$5.5 million would be directed towards the Emergency Rental Assistance Program.

Ms. Carrillo noted that the ARPA provided \$1.9 trillion to response efforts related to the COVID-19 Pandemic and she reviewed the support categories covered under the Act, which allotted 19% of funds to State and Local recovery.

Ms. Carrillo stated that City staff recommended a strategic and methodical approach to the appropriation of funds that focused on: 1) Financial stability, 2) Revenue loss recovery and 3) Immediate community needs. She added that the phased approach would first address revenue recovery and the second phase would address community priorities after FY 2022 Budget adoption.

Ms. Carrillo reviewed the estimated \$465.5 million in allocations to date to the City of San Antonio from ARPA:

- Fiscal Recovery - \$326.9M
- Housing Security - \$69.7M
- Airport Operations - \$38.3M
- Health Disparities - \$26.6M
- Head Start Programs - \$4.0M

Ms. Carrillo reiterated that the approval of Item 4 would allow the City to accept \$302.1 million in funding under the Act and reviewed the categories receiving funding:

- State and Local Recovery Funds - \$163.5M (First disbursement)
- Airport Operations - \$38.3M
- Emergency Rental Assistance – \$49.7M
- Health Disparities - \$26.6M
- Home Investment Partnerships Program - \$20.0M
- Head Start Program - \$4.0M

Ms. Carrillo noted that by accepting these funds the City would be able to extend the Emergency Housing Assistance Program through December 2021. She added that if approved, the Ordinance would bring forth various agreements totaling \$3.9 million to address health disparities.

Councilmember Courage noted that Item 4 covered a large scope of funding categories and discussed the need to separate the item into multiple parts in order to match the Staff Briefing Memo.

Councilmember Pelaez asked for clarification on the approval of reviewed funding and if it obligated to specific programs. City Manager Walsh reiterated that the approval by City Council would allow the City to accept funds primarily under the ARPA and would later determine specific programs based on guidelines provided by the Federal Government in Fall 2021. Councilmember Pelaez reminded all that the City Council had an obligation to assist everyone negatively impacted by the pandemic to include vulnerable populations.

Councilmember Castillo asked what defined low-barrier housing and if couples and pets could be housed at the facility. Melody Woosley, Director, Department of Human Services, stated that low-barrier meant that individuals with sobriety, mental health, lack of a Texas or other State identification

would be allowed to enter the facility. Ms. Woosley added that homeless couples were able to obtain services and housing at Haven for Hope and it was unlikely that they would qualify for the low-barrier facility since it would house chronically homeless individuals. Nakisha Baker with SAMMinistries stated that pet kenneling was not provided at the low-barrier facility due to cost restraints.

Councilmember Castillo asked about metrics used to define successful outcomes. Ms. Woosley stated that an anticipated 250 individuals would utilize the hotel facility over the course of a year with 65% of individuals engaging in case management, health assessments, and other activities that would prepare them for permanent housing placement and living options.

Councilmember Perry stated that he did not support Item 4A based on the fact that the City already spent \$50-\$80 million for homeless services and \$8.6 million provided to Haven for Hope for similar programs. He asked how many individuals were accounted for in the last Point In Time Homeless count. Ms. Woosley stated that approximately 3,000 were identified as homeless and 1,200 were identified as unsheltered. Councilmember Courage stated that he felt the proposed homeless services could be provided under the current City funding for homeless services.

Councilmember Perry asked if other cities utilized hotels as homeless shelters and what were their success metrics. Ms. Woosley stated the City of Austin utilized hotels as emergency shelters, but she would need to provide success metrics from the Austin's program. Councilmember Perry stated that the proposed funding should have been reviewed at the Council Committee level.

Councilmember Viagran asked how many rooms were dedicated to the low-barrier housing and if City staff would be present at the facility. Ms. Woosley stated that 50 rooms would be contracted in the agreement with 45 to 47 rooms utilized as housing with SAMMinistries staff managing the facility.

Councilmember Viagran asked how security would be handled at the facility. Ms. Woosley stated that security was currently budgeted for one security guard to be present 24 hours a day and two guards present during nighttime hours (8 PM to 8 AM).

Councilmember Rocha Garcia asked if pets of homeless individuals could be housed at Animal Care Services (ACS) or partner facilities. Ms. Woosley stated that Haven for Hope had kennels at their facility which were often filled. She added that Haven for Hope worked with ACS to house additional animals and would coordinate the same with the hotel project.

Councilmember Sandoval stated that she supported this project which was critical and important to addressing alternate homeless housing needs. She stressed the importance of the City Council playing a larger role in the development of these types of policies. She asked that City Council be provided more detailed briefing materials in advance of making these type of funding decisions. City Manager Walsh noted that discussions on this subject matter had been provided at different City Council briefings to include B Sessions addressing ARPA or CARES Act funding. He emphasized the importance of addressing these type items to the purview of the 11 member City Council body and not at the Council Committee level, but that staff would aim to provide more detailed reports.

Councilmember Sandoval asked if mental health or substance abuse support would be provided to residents. She proposed that a coordinated response to the homeless issue be addressed at the Budget Goal Setting Session related to these proposed funds. City Manager Walsh clarified that substance abuse and mental health services were budgeted and built into the contract with SAMMinistries. He added that some of the services would be provided on site and referrals to other service facilities would

also be covered under the program.

Councilmember Sandoval asked if staff had visited the Austin Homeless Emergency Shelter. Ms. Woosley stated that City staff had not visited the site but that SAMMinistries had visited with several homeless service providers across the Country that have implemented similar programs. She added that staff was incorporating a report based on their feedback.

Councilmember McKee-Rodriguez noted his support for this Item and stated that he felt it addressed service gaps related to mental health and substance abuse.

Councilmember Pelaez noted his support for the Item especially in anticipation of the upcoming Summer heat and current need for services provided.

Councilmember Courage stressed the importance that funding programs, even if a pilot program, be reviewed at the Council Committee level. He recognized the seriousness of homeless conditions and asked that City-wide funding be evaluated to assure that there was not waste or gaps in services.

Councilmember Bravo asked how the City defined a Housing First Policy. Ms. Woosley stated that the Housing First Policy immediately placed a person on the street into permanent housing and they did not have to go through a six month to two year program to earn housing, and that a coordinated entry system was in place to assess and prioritize the most vulnerable for housing. She added that housing partners worked together to ensure that individuals were going through the coordinated system to obtain Federally subsidized permanent housing.

Councilmember Bravo asked if SAMMinistries met the City's Housing First definition and approach. Ms. Woosley stated that they did. He stated that he shared other Councilmembers concerns on having a thorough public input process and ability to review all components of proposed policy. He stressed that the City needed to be good stewards of the community's tax dollars.

Councilmember Perry asked why a Request for Proposal (RFP) for the Program requirements was not issued and noted that he considered this a direct award. City Manager Walsh stated that initially programs such as this were done in response to Emergency Response efforts. He agreed that normal solicitation processes should be followed in the future and that the City was returning to pre-pandemic practices for procurement. City Manager Walsh noted that an RFP process had been utilized for other homeless initiatives receiving funding but was not used for the hotel concept.

Councilmember Bravo asked if a lack of gathered data and grant writers hindered the City's efforts to obtain Federal grants. Assistant City Manager Lori Houston stated that the City had obtained significant data and had proven successful in obtaining Federal grants for homelessness and other initiatives. She committed to meeting with Councilmembers to assess sought out data for future grant submission efforts.

City Attorney Andy Segovia clarified that the Low-Barrier Housing Pilot Program did go through an appropriate solicitation process. City Attorney Trey Shaw explained that the funds utilized for the Program were part of the Recovery and Resiliency Plan Ordinance approved by City Council. He stated that the approved Ordinance allowed for emergency processes to take place and allowed coordination of initiatives through approved partners for emergency services.

Mayor Nirenberg stated that the urgent nature of homelessness guided the process for grant submittals.

He stressed that the City needed to continue to utilize all forms of housing options when addressing homelessness and understood his City Council colleagues frustrations on amounts of funding provided towards homeless issues with continued challenges. He recognized the City and partners efforts to combat and address homelessness and asked his City Council colleagues to continue to support homelessness provider services.

Mayor Nirenberg asked how the hotel lease agreement and the Housing First Program related to the City's Strategic Plan. Ms. Woosley stated that a key recommendation of the Strategic Plan was to identify additional low-barrier shelters and provide services for mental health, trauma, and substance abuse issues.

Councilmember Sandoval stated that she was pleased to see that the contract with UT Health Science Center was continuing along with the assistance provided by Dr. Barbara Taylor. She asked if funding for the Community Response and Equity Coalition (CREC) would continue. Ms. Woosley stated that a main reason for the two-year extension was to begin transition from the CREC into the recovery aspect of the Pandemic. She noted the associated contract paid for the expertise services of Dr. Taylor and her work on the CREC and added that other health disparity grants would be utilized to address the work of CREC.

Councilmember Castillo noted that it was important to remember that the moratorium on housing evictions expired on June 30, 2021. She stated that the City had an opportunity to further invest in Emergency Housing Assistance Program.

Councilmember Courage moved to separate Item 4 into multiple parts, so they matched sections 4A, 4B, 4C, 4D, 4E and 4F as covered in the Briefing Memo. Councilmember Rocha Garcia seconded the motion. The motion prevailed by the following vote:

She noted that the tool would be highly useful in measuring of outcomes and metrics related to the Strategic Growth Plan and its four priority areas of mental health, health justice, technology and infrastructure, and access to care.

Ana Bradshaw, Assistant Director, Economic Development Department, stated that the department would utilize the tool to highlight Opportunity Zones throughout the City and provide key demographics associated with the zones.

Councilmember Sandoval asked if there was an opportunity to see the tool prior to roll out and learn about what metrics it would track. Dr. Agha stated that there would be an opportunity to observe the associated external public facing dashboard associated with the Strategic Growth Plan metrics. She noted that the mySidewalk tool would be rolled out in Spring 2022.

Mayor Nirenberg thanked the Metro Health Team for their continued efforts in providing quality data associated with City health programs especially during COVID -19 Pandemic challenges.
