The following high profile solicitation has completed the solicitation process. This item is presented to the Audit and Accountability Committee for review prior to full City Council consideration.

Integrated Library System - The San Antonio Public Library (SAPL) solicited proposals from qualified respondents interested in furnishing an Integrated Library System. The Library, in support of its overall mission, strives to ensure seamless access to excellent library service through the acquisition of a new Integrated Library System. A new Integrated Library System will support library staff and its patrons in their goals with efficient workflows, adherence to both library industry and technology standards and best practices, provide staff access to statistical data on both system use and inventory, provide self-service opportunities for patrons, provide access controls to protect patron privacy and be scalable and adaptable for future growth and needs.

Due diligence conducted for the respondents to the above solicitation included a search of federal and state debarment lists, prohibited political contributions, conflicts of interest, delinquent City/County taxes, outstanding payments to the City, payment of state franchise fees as well as a search of the internet for pertinent business information. No findings were noted that would prevent the City from awarding to the selected vendor.

Staff recommends committee approval to proceed with scheduling this item for full City Council consideration.
