**Property Details**

**Property History:** The property is currently zoned “R-5” Residential Single-Family District. The property was originally annexed on September 24, 1964 (Ordinance 32609). The property was zoned Temporary “A” Residential District. On 1965 the property was rezoned as R-5 with the implementation of the 1965 Zoning District. Upon the adoption of the 2001 Unified Development Code, the zoning district retained the "R-5" Residential Single-Family District classification.

**Topography:** The property does not include any abnormal physical features such as slope or inclusion in a flood plain.

**Adjacent Base Zoning and Land Uses**

**Direction:** North, East

**Current Base Zoning:** “R-5”

**Current Land Uses:** San Antonio International Airport, manufacturing businesses.

**Direction:** West, South

**Current Base Zoning:** “R-5”

**Current Land Uses:** manufacturing businesses.

**Overlay and Special District Information:** All surrounding properties carry the "AHOD" Airport Hazard Overlay District, due to their proximity to an airport or approach path. The “AHOD” does not restrict permitted uses, but can require additional review of construction plans by both the Development Services Department and the Federal Aviation Administration.

**Transportation**

**Thoroughfare:** Turbo Drive

**Existing Character:** Local

**Proposed Changes:** None known

**Public Transit:** None.

**Traffic Impact** A Traffic Impact Analysis (TIA) is not required. The traffic generated by the proposed development does not exceed the threshold requirements.

**Parking Information:** Manufacturing: 1 spaces per 1,500 sf. GFA. Maximum Parking Requirement: 1 spaces per 300 sf. GFA.

**ISSUE:**

**ALTERNATIVES:**

Denial of the zoning request will result in the subject property retaining the “R-5” residential zoning.

**FISCAL IMPACT:**

None.

**RECOMMENDATION:**

**Staff Analysis and Recommendation:** Staff and Zoning Commission (8-0) recommend Approval.

**Criteria for Review:** According to Section 35-421, zoning amendments shall be based on the approval criteria below.

**1. Consistency:**

The property is located within the San Antonio International Airport Vicinity Land Use Plan and is designated as Light Industrial. The requested “I-1” base zoning district is consistent with the adopted land use designation.

**2. Adverse Impacts on Neighboring Lands:**

Staff has found no evidence of likely adverse impacts on surrounding properties.

**3. Suitability as Presently Zoned:**

The proposed “I-1” zoning district is appropriate for the subject property. The applicant requests this zoning change in order to bring the subject property to compliance with the UDC. The requested use is consistent with the existing development pattern.

**4. Health, Safety and Welfare:**

Staff has found no indication of likely adverse effects on the public health, safety, or welfare.

**5. Public Policy:**

The request does not appear to conflict with any public policy objective.

**6. Size of Tract:**

The subject property is 1.9556 acres in size, which accommodates the proposed development with adequate space for parking.

**7. Other Factors:**

None.
