### **BACKGROUND INFORMATION:**

Applications from qualified applicants for Council District Representatives were forwarded to the respective City Council Offices for review and consideration. A memorandum was submitted to the Office of the City Clerk by the Mayor or Councilmember designating an appointee for processing. Applications from qualified applicants for At-Large Representatives were forwarded to the designated Council Committee for review and consideration with recommendations to be considered by the full Council.
