SUMMARY:

There is one (1) additional Business Community slot for the remainder of an unexpired term of office vacated by the appointment of Councilmember Roberto C. Treviño. The applicants listed below qualify for appointment. Applicants who are not residents of the City of San Antonio will require a waiver for appointment.
