Huffstutler, Alexander Riedel, and George C. Meketa for this appointment.

**BACKGROUND INFORMATION:**

The Economic and Human Development City Council Committee convened on June 1, 2016 and provided

recommendations for appointments to the Airport Advisory Commission for the remainder of unexpired terms of office to expire March 18, 2018. The appointment for the Airport Business Lessee category is for the remainder of an unexpired term of office to expire March 18, 2017.
