Property History: The subject property was annexed into the City of San Antonio in 1952 and was previously zoned "B" Residence District. Upon adoption of the 2001 Unified Development Code, the previous base zoning district converted to the current "R-4" Single-Family Residential District

Topography: The property does not include any abnormal physical features such as slope or inclusion in a floodplain.

The "AHOD" does not restrict permitted uses, but can require additional review of construction plans by both the Development Services Department and the Federal Aviation Administration

ALTERNATIVES:

A denial of the request will result in the subject property retaining the current "R-4 AHOD" Single-Family Residential Airport Hazard Overlay District.

FISCAL IMPACT:

RECOMMENDATION:

Staff Analysis and Recommendation: Staff recommends Denial. Zoning Commission (10-0) recommends approval.

Criteria for Review: According to Section 35-421, zoning amendments shall be based on the approval criteria below.

1. Consistency:

The property is located within the Stinson Airport Vicinity Land Use Plan, and is currently designated as Low Density Residential in the future land use component of the plan. The requested "C-1" Commercial base zoning district is not consistent with the future land use designation. The applicant has requested a Plan Amendment to change the land use from Low Density Residential to Community Commercial. Staff and Planning Commission recommend denial.

2. Adverse Impacts on Neighboring Lands:

A change to commercial within an established residential subdivision could result in increased traffic and inappropriate commercial uses.

3. Suitability as Presently Zoned:

The current "R-4" base zoning district is appropriate for the subject property's location. The adjacent properties are zoned "R-4" which works in conjunction with surrounding single family dwellings and zoning districts.

4. Health, Safety and Welfare:

Staff has found no indication of likely adverse effects on the public health, safety, or welfare.

5. Public Policy:

The rezoning request does appear to conflict with land uses goals and strategies of the Stinson Airport Vicinity Land Use Plan as it plans to protect the quality of life of residents including health, safety and welfare by protecting the integrity of existing residential neighborhoods.

6. Size of Tract:

The subject property totals 0.6831 acres in size, which should reasonably accommodate the uses permitted in "C-1" Commercial District.

7. Other Factors:
