SUMMARY:

Picoso, described as 100 feet of Lots 10, 11 and 12, or Red E and F, ARB A-12, and A-11, Block 13, New City Block 3049; 1014 Romero, described as Lot 7 and south 1/2 of Lot 6, Block 6, New City Block 8094; 3106

BACKGROUND INFORMATION:

The City of San Antonio's Transportation & Capital Improvements Department is requesting to declare as surplus and dispose of nine (9) vacant tracts of City-owned real properties in Council District 5, as shown on Exhibit "A." If approved, the City of San Antonio will dispose of the property in accordance with Chapter 272 of the Local Government Code.

ISSUE:

ALTERNATIVES:
