SUBJECT:

Disposition: Closure of an unimproved portion of Applewhite Street

SUMMARY:

An ordinance closing, vacating, and abandoning 0.146 of an acre of an unimproved portion of Applewhite Street public right-of-way, located between 1602 South Flores Street and 202 Peters 1, in Council District 5, as requested by SOFLO OF SA LLC, for a fee of \$48,355.00.

BACKGROUND INFORMATION:

SOFLO OF SA LLC, Petitioner, is requesting the closure, vacation, and abandonment of an unimproved 0.146 of an acre (6,356 square feet) of Applewhite Street public right-of-way, as shown on attached Exhibit "A". Petitioner is the sole abutting property owner. With the approval of the proposed closure, the properties would be combined and platted into a unified parcel of land which would facilitate future development of the site. The current zoning of the petitioner's property is I-1 General Industrial District and I-2 Heavy Industrial District.

ISSUE:

SOFLO OF SA LLC (Petitioner) is requesting the closure, vacation, and abandonment of an unimproved 0.146 of an acre (6,356) square feet of Applewhite Street public right-of-way, as shown on attached Exhibit "A". Petitioner is the sole abutting property owner. If approved, the petitioner intends to combine and plat the properties into a unified parcel of land, which would facilitate future development of the site.

This action is consistent with City Code and Ordinances, which require City Council approval for the sale or disposition of Cityowned or controlled real property. The Planning Commission approved this request at its regular meeting on March 28, 2018.

ALTERNATIVES:

The City Council could choose not to approve this request; however, if not approved, the right-of-way will remain underutilized.

FISCAL IMPACT:

The fee established for this property is 48,305.00 utilizing Bexar County Appraisal District assessed land values as provided by Chapter 37, section 2(g)(2) of the City Code. With added administrative costs, the City will collect a total of 48,355.00 for this property, and the revenue will be deposited into the General Fund in accordance with the FY 2018 Adopted Budget.

The property will be placed on the tax rolls, generating revenue for the City of San Antonio and other taxing entities.

RECOMMENDATION:

Staff recommends approval of this request to close, vacate, and abandon an unimproved portion of Applewhite Street public rightof-way in Council District 5.

The City of San Antonio's Planning Commission approved this request at its regular meeting on March 28, 2018.
