SUBJECT:

An Ordinance amending Chapter 5 of the City Code to require animals have access to shade as a required Standard of Care.

SUMMARY:

An Ordinance amending Chapter 5 of the City Code to require animals have access to shade as a required Standard of Care.

BACKGROUND INFORMATION:

The City's Animal Care Services Department mission is to encourage responsible pet ownership by promoting and protecting the health, safety, and welfare of the residents and pets of San Antonio through education, enforcement, and community partnership. Since 2006, the City of San Antonio has taken progressive steps to ensure the public safety of San Antonio residents while implementing more humane practices for the care and treatment of all animals.

To ensure and promote the humane treatment of animals in San Antonio, the City is governed by Chapter 5 of the City code which is a framework of humane laws and policies to ensure the protection of both pets and people. Chapter 5 of the City code establishes a minimum Standard of Care to safeguard humane care and treatment of pets.

In October 2017, City Council unanimously approved revisions to Chapter 5 of the City Code. These changes were based on input from City residents, stakeholders, and the ACS Advisory Board Subcommittee. Key revisions to Chapter of the City Code included increased/improved:

- (1) Spay/neuter requirements for pets found in violation of City code.
- (2) Tethering regulations for dogs
- (3) Impoundment authority for pets being sold at unauthorized locations
- (4) Animal limits for domesticated fowl
- (5) Dangerous dog designation requirements
- (6) Enforcement of animal related noise complaints

The current Standard of Care requires pet owner to provide owned pets: (1) Access to an adequate supply of fresh air; (2) Species-specific food; (3) Fresh water; (4) Exercise; (5) Shelter; and (6) Veterinary care when needed to prevent suffering. In addition, Chapter 5 of City code currently requires an animal access to shade when it is being tethered. Violation of this ordinance can result in the issuance of civil and criminal citations with a financial penalty in the amount of up to \$2,000 per occurrence.

During the months of June through September, San Antonio can reach temperatures well above 90°Fahrenheit. Access to shade (in addition to shelter) helps with a dogs' ability to regulate their body temperature during extreme heat. Dogs are vulnerable to injuries and illnesses related to hot weather including heat stroke, sunburn, and foot pad burns.

ISSUE:

This presentation will provide City Council with a recommended revision to Chapter 5 of the City code that will require all owned or kept animals have access to shade, whether natural or artificial at all times, and allow ACS to issue civil and/or criminal citations to those found in violation. The Animal Care Services Advisory Board is supportive of this recommendation. A briefing to City Council on the proposed amendment is scheduled at a "B" Session on August 1, 2018.

The change to Chapter 5 of the City Code would become effective immediately after City Council Approval.

ALTERNATIVES:

Should this recommendation not be approved, Animal Care Services will continue to operate under the current Chapter 5 City code where access to shade is not a required standard of care. ACS will continue to engage residents and recommend to them the need to provide adequate shade for pets being housed outside; however, ACS would be unable to enforce the recommendation as a requirement.

FISCAL IMPACT:

This Ordinance has no fiscal impact.

RECOMMENDATION:

Staff recommends City Council approval of this Ordinance amending Chapter 5 of the San Antonio City Code.
