The following high profile project has completed the solicitation process. This item is presented to the Audit and Accountability Committee for review prior to full City Council for consideration.

On-Call Outside Environmental Remediation Services (Aviation) - City of San Antonio solicited proposals from qualified firms to provide the San Antonio Airport System with three, \$1.5 Million contracts for emergency on-call services to respond to sewer and water overflows, biohazard cleanups, or fuel spills on Airport property.

• Contract Value: \$4.5 Million (3 contracts at \$1.5 Million each)

• Term of Contract: 3 years with 2, 1 year options

Due diligence conducted for the respondents to the above solicitations included a search of federal and state debarment lists, prohibited political contributions, conflicts of interest, delinquent City/County taxes, outstanding payments to the City, payment of state franchise fees as well as a search of the internet for pertinent business information. No findings were noted that would prevent the City from awarding to the selected vendors.
