### BACKGROUND INFORMATION:

This briefing is part of the ongoing process of keeping Council informed of the activities of the City owned utilities. CPS Energy and the San Antonio Water System (SAWS) provide status reports to Council in alternating months.

SAWS serves more than 500,000 water and 450,000 wastewater customers in and around San Antonio and maintains over 12,600 miles of water and sewer mains.

SAWS is governed by a seven-member Board of Trustees with the Mayor serving as an ex-officio member. The City Council exercises its oversight of SAWS through the approval of rates and charges, authorization of debt issuances, approval of all condemnations, and the appointment of all Trustees except the Mayor.
