Funding Agreement: UTSA Athletics Complex (2017 Bond Project)

SUMMARY:

An ordinance authorizing the negotiation and execution of a funding agreement between the Roadrunner Athletic Foundation and the City of San Antonio in an amount not to exceed \$10,000,000.00 for improvements to University of Texas at San Antonio (UTSA) Athletics Complex, a 2017-2022 Bond Funded Project.

BACKGROUND INFORMATION:

On May 6, 2017, San Antonio residents voted and approved the 2017-2022 General Obligation Bond Program totaling \$850 million. The Bond Program funds will be used on various capital improvement projects addressing community infrastructure needs to improve the overall quality of life in San Antonio. As part of the program, \$10,000,000.00 in Parks, Recreation and Open Space Improvements General Obligation Bond Funds

was approved for improvements towards improvements to University of Texas at San Antonio (UTSA) Athletics Complex to include but not limited to locker rooms, showers and restrooms.

UTSA is a multicultural university institution with more than 32,000 students and it the largest university in the San Antonio metropolitan region. UTSA is planning on constructing a \$44 million new Roadrunner Athletics Center of Excellence which will serve as a hub for the 350+ student-athletes participating in 17 NCAA Division I sport programs at UTSA. The center is intended to serve as a comprehensive multi-purpose sports performance center with a focus on providing resources that address student-athlete academic success, safety, performance and wellness.

The 2017-2022 Bond funds will support the associated improvements for UTSA Roadrunner Athletics Center of Excellence. The City's funding will go toward the construction of UTSA Roadrunner Athletics Center of Excellence soccer and track facility and outdoor grass practice fields.

ISSUE:

This ordinance authorizing the negotiation and execution of a funding agreement between the Roadrunner Athletic Foundation and the City of San Antonio in an amount not to exceed \$10,000,000.00 for improvements to University of Texas at San Antonio (UTSA) Athletics Complex, a 2017-2022 Bond Funded Project.

The 2017-2022 Bond funds will support the associated improvements for UTSA Roadrunner Athletics Center of Excellence. The City's funding will go toward the construction of UTSA Roadrunner Athletics Center of Excellence soccer and track facility and outdoor grass practice fields.

Construction will be overseen by UTSA and is expected to be completed in December 2021. Funding will be provided on a reimbursement basis and upon construction verification and approval.

ALTERNATIVES:

City Council could choose not to approve the agreement; however, doing so would delay the City delivering the voter approved Bond project for the UTSA Athletics Complex and impact the UTSA students and surrounding community.

FISCAL IMPACT:

This is a one-time capital improvement expenditure in an amount not to exceed \$10,000,000.00 payable to Roadrunner Athletic Foundation. Funds are available from the 2017-2022 General Obligation Bond Program and included in the FY 2019- FY 2024 Capital Improvement Program Budget.

RECOMMENDATION:

Staff recommends the approval of a funding agreement between the Roadrunner Athletic Foundation and the City of San Antonio in an amount not to exceed \$10,000,000.00 for improvements to University of Texas at San Antonio (UTSA) Athletics Complex, a 2017-2022 Bond Funded Project.
