**BACKGROUND INFORMATION:**

VIA manages and operates the Metropolitan Transit Authority within Bexar County, Texas. VIA is governed by a Board of Trustees with eleven appointees, five (5) of which are appointed by the San Antonio City Council; three (3) are appointed by the Bexar County Commissioners Court; two (2) are appointed by the Suburban Mayors; and the Chair of the Board is elected by the Board Members. Board members serve staggered two-year terms and may serve up to four terms.

**ISSUE:**

Board appointments require full City Council approval.

**FISCAL IMPACT:**

There is no fiscal impact.

**RECOMMENDATION:**

The City Clerk recommends approval for the Governance City Council Committee's recommendations of individuals to be interviewed at the Governance City Council Committee Meeting on August 21, 2019.
