Planning Commission Meeting Schedule November 2020 - December 2020

#### **SUMMARY:**

Consideration of a Resolution to reschedule the Planning Commission meetings of November 11, 2020, November 25, 2020, December 9, 2020, and December 25, 2020.

#### **BACKGROUND INFORMATION:**

To ensure a quorum is maintained during the November and December 2020 public hearings, the Development Services Department (DSD) is recommending changes to the Planning Commission schedule for several meeting dates.

This year the City of San Antonio offices will be closed on November 11, 2020. Additionally, the Planning Commission currently has a meeting scheduled on November 25<sup>th</sup>, 2020, the day before the City closure for the Thanksgiving holiday, December 9, 2020, and on December 23<sup>rd</sup>, 2020, the day before the City Winter Holiday closure. Staff proposes to cancel the meetings of November 11<sup>th</sup>, 2020, November 25<sup>th</sup>, 2020, December 9<sup>th</sup>, 2020, and December 23<sup>rd</sup>, 2020 and propose an alternate meeting dates of Wednesday November 18<sup>th</sup>, 2020 and December 16<sup>th</sup>, 2020.

Staff recommends approval of cancelling and rescheduling meetings, as shown below, to ensure that projects continue to move forward in a timely manner in adherence to the Unified Development Code (UDC) and State Law timelines. Rescheduled meetings will begin at 9:00AM.
