Annual Contract for Elevator & Escalator Preventive Maintenance, Inspection, and Repair Services (Aviation) - The City of San Antonio is soliciting proposals for a contractor to provide a preventive maintenance, inspection, and repair program to ensure the safety and functionality of 22 elevators and 21 escalators located at the San Antonio International Airport and Stinson Municipal Airport.
