**SUMMARY:**

Of the five (5) slots available; four (4) slots terms of office expire on October 6, 2021 and one (1) slot is to fill an unexpired term of office until October 6, 2020. This is due to the resignation of Jennifer Ramos. Three (3) applicants are seeking reappointment and were selected by the Planning Commission Subcommittee for interviews.
