**SUBJECT:** Consideration of a Completed High Profile Solicitation

**DATE:** March 17, 2020

The following high-profile project has completed the solicitation process. This item is presented to the Audit and Accountability Committee for review prior to the full City Council for consideration.

**Financial Consulting Services for San Antonio International Airport** - City of San Antonio solicited proposals from qualified firms to provide financial consulting services to include but not limited to: preparation of Passenger Facility Charge (PFC) applications, assistance with issuance of future General Aviation Revenue Bonds and PFC Bonds, forecasting of airline rates and charges and modeling of Capital Improvements Plan (CIP), negotiation of Airline Lease and Use Agreement, and provision of other financial planning services such as financial feasibility services for the implementation of the Strategic Development Plan CIP, etc.

• Solicitation Type: Request for Proposals

• Contract Value: \$1,600,000

• Term of Contract: 3 years with 2, 1 year renewal options

Due diligence conducted for the respondents to the above solicitations included a search of federal and state debarment lists, prohibited political contributions, conflicts of interest, delinquent City/County taxes, outstanding payments to the City, payment of state franchise fees as well as a search of the internet for pertinent business information. No findings were noted that would prevent the City from awarding to the selected vendor.

Staff recommends committee approval to proceed with scheduling this item for full City Council consideration.
